Schedule II - Benelux

Section D - Netherlands Antilles

On 18 November 1960, the CONTRACTING PARTIES granted the Kingdom of the Netherlands an extension of time, until 30 November 1960, for the notification of items bound in Schedule II - Benelux, Section D - Netherlands Antilles for renegotiation under Article XXVIII during the 1960-61 Tariff Conference (SR.17/10).

The list of items bound in Section D of Schedule II which the Government of the Kingdom of the Netherlands wishes to negotiate under the procedures of paragraph 1 of Article XXVIII is attached hereto.
