ARTICLE XXVIII:5 NEGOTIATIONS

Schedule I - Commonwealth of Australia

1. The Government of the Commonwealth of Australia has notified the CONTRACTING PARTIES that it reserves the right, for the duration of the three-year period beginning 1 January 1967, to modify its Schedule in accordance with the provisions of paragraph 5 of Article XXVIII (document L/2718).
2. Pursuant to this notification the Government of Australia intends to withdraw or modify the concessions listed in the annex attached hereto.
