Renégociations au titre de la dérogation du 16 mars 1973

Le 16 mars 1973, les PARTIES CONTRACTANTES ont décidé de suspendre l'application des dispositions de l'article II de l'Accord général dans la mesure nécessaire pour que le gouvernement de l'Inde puisse appliquer les taux de droits résultant de la rationalisation de son tarif douanier qui dépasseraient les droits consolidés dans la Liste XII, en attendant l'aboutissement des négociations au titre de l'article XXVIII tendant à la modification ou au retrait des concessions reprises dans cette Liste (L/3831; IBDD, Supplément n° 20, page 28)¹.

La liste des concessions tarifaires retirées figure dans le document L/3874 et addenda.

Le gouvernement de l'Inde a maintenant informé le secrétariat que les renégociations ont abouti. Les résultats (en anglais seulement) des négociations menées entre l'Inde et les pays ci-après sont joints en annexe:
