Le gouvernement sud-africain a pris note de l'importance que les Etats-Unis attachent à ce qu'il entreprenne sans tarder une action appropriée en vue d'aligner complètement les mesures de contrôle qu'il applique actuellement à l'importation sur les obligations qui lui incombent au titre de l'Accord général.

A cet égard, le gouvernement sud-africain tient à confirmer que sa politique est de libéraliser progressivement ses restrictions quantitatives à mesure qu'aboutiront les négociations qu'il a entamées au titre de l'article XXVIII et qui ont pour but de lui assurer la liberté nécessaire pour accorder aux industries sud-africaines qui le méritent une protection tarifaire raisonnable, sur une base sélective.

En conséquence, le gouvernement sud-africain s'engage à garantir la libre délivrance de licences d'importation pour les produits de la liste ci-jointe qui reprend les négociations qu'il a entamées avec le gouvernement des Etats-Unis d'Amérique au titre de l'article XXVIII.

Le présent engagement est pris sans préjudice des droits que l'Afrique du Sud pourrait faire valoir, dans l'avenir, au titre de l'Accord général. Il est entendu que le gouvernement des Etats-Unis réserve ses droits au titre de ce même instrument en ce qui concerne les restrictions quantitatives qui ne sont pas explicitement visées par le présent engagement.
