Addendum

The following communication, dated 10 November 1982, has been received from the Permanent Mission of Indonesia.

I have the honour to transmit herewith copy of the bilateral agreement¹ between the Government of the Republic of Indonesia and the Government of Japan on the establishment of a new Schedule XXI - Indonesia under GATT Article XXVIII.

I further wish to inform you that negotiations are still being conducted on this Schedule with the Governments of Canada, Czechoslovakia, Finland and New Zealand. It is hoped that these could be concluded before the end of this year.

On espère que ces négociations pourront être menées à terme avant la fin de cette année.




