¹The annual quota for broken rice of sub-headings Nos. 1006.40 ex A and ex B amounts to 1,000 metric tons in the whole for factories for the manufacture of preparations of sub-heading No. 1901.10. The granting of this concession is conditional upon the presentation of a certificate ("Kontingentschein") drawn up by the Federal Minister of Economic Affairs, which is responsible for monitoring and allocating the quota. The quota year begins on 1 January of each year. For the year 1988, the quota will be fixed on a pro rata basis in relation to the annual quota.
