NEGOCIATIONS AU TITRE DU PARAGRAPHE 5 DE L'ARTICLE XXVIII

LISTE I - COMMONWEALTH D'AUSTRALIE

La Mission permanente de l'Australie a fait parvenir au secrétariat la communication ci-après en date du 2 mars 1987.

J'ai l'honneur de me référer au document du GATT TAR/90, en date du 20 novembre 1984, par lequel l'Australie a fait savoir aux PARTIES CONTRACTANTES que, conformément aux dispositions du paragraphe 5 de l'article XXVIII de l'Accord général, elle se réservait le droit de modifier sa liste de concessions au cours de la période triennale commençant le 1er janvier 1985.

Comme suite à cette notification et d'ordre des autorités de mon pays, j'ai l'honneur de porter à votre connaissance que l'Australie a l'intention, conformément aux dispositions du paragraphe 5 de l'article XXVIII de l'Accord général, de retirer les concessions consolidées reprises dans la Liste I - Australie, qui sont énumérées ci-après.¹
