NEGOCIATIONS AU TITRE DU PARAGRAPHE 5 DE L'ARTICLE XXVIII

Liste I - Commonwealth d'Australie

La Mission permanente de l'Australie a fait parvenir au secrétariat la communication ci-après le 24 septembre 1987.

J'ai l'honneur de me référer au document du GATT TAR/90, en date du 20 novembre 1984, par lequel l'Australie a fait savoir aux PARTIES CONTRACTANTES que, conformément aux dispositions du paragraphe 5 de l'article XXVIII de l'Accord général, elle se réservait le droit de modifier sa liste de concessions au cours de la période triennale commençant le 1er janvier 1985.

Comme suite à cette notification et d'ordre des autorités de mon pays, j'ai l'honneur de porter à votre connaissance que l'Australie a l'intention, conformément aux dispositions du paragraphe 5 de l'article XXVIII de l'Accord général¹, de modifier certaines concessions énumérées dans le document ci-joint.

Des tableaux présentant les statistiques commerciales pertinentes sont joints à la présente notification.

L'Australie est disposée à engager des négociations ou des consultations, conformément aux dispositions de l'article XXVIII en la matière. Toute partie contractante estimant avoir un intérêt dans ces concessions est priée de le faire savoir dans un délai de 90 jours à compter de la date de la présente communication.
