SCHEDULE XXIV - FINLAND

Results of Negotiations under Article XXVIII:4 (Revised)

The Government of Finland was authorized by the Intersessional Committee on 23 September 1955 (see IC/SR.21 and L/413) to negotiate certain items bound in Schedule XXIV, and listed in documents SECRET/52 and Add.1.

Negotiations have been concluded with France and the United Kingdom, the two contracting parties with which the items in question had been initially negotiated. The results of these negotiations are attached hereto.
