Results of Renegotiations

On 15 January 1957 the Intersessional Committee granted authority to Canada to enter into renegotiations under Article XXVIII:4 for the modification of the concession on Item 83(a) in Part I of Schedule V. The negotiation was conducted with the United States. No other contracting party claimed an interest.

The Government of Canada has submitted the attached announcement of the results of the negotiations; these involve modification of concessions in Schedule XX (United States) as well as in Schedule V.

Provided further, That in computing the quantity of imports specified in the foregoing provisos to this item, white or Irish potatoes produced in the Republic of Cuba shall not be included.
