Please refer to the recommendation of the Textiles Surveillance Body dated 13 May 1977, in regard to the question of the provision for growth rate in the bilateral agreements concluded between Sweden and Pakistan on 10 September 1976 and 28 February 1977. The two parties have agreed to submit the following report:

Consultations were held between Sweden and Pakistan in pursuance of this recommendation. The consultations remained inconclusive. Both sides agreed to keep the matter open for further consultations with a view to arriving at mutually acceptable agreement. The Textiles Surveillance Body will be informed of the upshot of these consultations as soon as possible or necessary.
