Dear Ambassador Wurth,

Please find enclosed a Memorandum of Understanding setting out the arrangement which has been agreed upon between the Government of the Kingdom of Norway and the Government of the Republic of the Philippines regarding the exports from the Philippines to Norway of certain textile products.

Enclosed is also a short reasoned statement concerning this Agreement which was signed in Manila on 20 June 1977. The Agreement covers the period 1 October 1976 to 31 December 1977 for woven shirts, and the year 1977 for the other items.

MEMORANDUM OF UNDERSTANDING

1. This Memorandum of Understanding sets out the Arrangement that has been agreed upon between the Government of the Kingdom of Norway and the Government of the Republic of the Philippines regarding the exports from the Philippines to Norway of certain textile products which are set out in the Annex to this Memorandum.
2. In reaching agreement on this Arrangement the Authorities of the two countries have had regard to the provisions of Article 4 of the Arrangement Regarding International Trade in Textiles, in order to ensure the orderly development of trade in textiles between the two countries.
3. The Government of the Republic of the Philippines will voluntarily restrain the exports to Norway of the textile items listed in the Annex to the limits listed in column (e), for the periods listed in column (d) of the mentioned Annex.
4. The Government of the Republic of the Philippines will issue export certificates stating that the export to Norway of the textile items mentioned in the Annex are of Philippine origin and debited to the restraint limits.
5. The Government of the Kingdom of Norway will automatically issue import licenses up to the agreed levels whenever export certificates as described in paragraph (4) are produced.
6. If at the end of 1977 exports of the items mentioned in the Annex are less than the respective restraint limits, additional exports, equivalent to such shortfalls, may take place during 1978, provided that such additional exports do not exceed 10 percent of the restraint limits.

7. The exports of the items mentioned in the Annex may exceed the respective restraint limits by 7 percent provided that corresponding deductions are made from any limits which may be agreed in respect of the same textile products in the immediately following restraint period.
8. The carryover mentioned in paragraph 6, and the carry forward mentioned in paragraph 7, taken together shall not exceed 10 percent of the agreed levels listed in column (e) of the Annex.
9. Exports may exceed the restraint limits for any of the categories by not more than 7 percent, provided that a corresponding reduction is applied in any other category in the same period. For the purpose of calculating such corresponding reductions, the conversion factors listed in column (f) of the Annex shall apply.
10. The Government of the Republic of the Philippines will provide the Government of the Kingdom of Norway with quarterly statistics of the licences issued for export to Norway of the items mentioned in the Annex.
11. The Government of the Kingdom of Norway will provide the Government of the Republic of the Philippines with quarterly statistics on the importation into Norway of the items mentioned in the Annex.
12. If the Government of the Republic of the Philippines considers that as a result of the restraint imposed by this Arrangement, the Philippines is being placed in an inequitable position vis-a-vis a third country, the Government of the Republic of the Philippines may request the Government of the Kingdom of Norway to consult with a view to appropriate remedial action such as a reasonable modification of this Arrangement.

13. The Government of the Kingdom of Norway will, so far as possible, inform the Government of the Republic of the Philippines when imports into Norway of garments that have been debited to the agreed limits are subsequently re-exported from Norway. The Government of the Republic of the Philippines may then credit the quantities involved to the appropriate limits.
14. The Government of the Republic of the Philippines and the Government of the Kingdom of Norway agree to consult together at the request of either party, on any matter arising from the implementation of this Arrangement.

Short reasoned statement.

Consultations between the Government of Norway and the Government of the Philippines with regard to the exports of certain garments from the Philippines started in Manila 24-25 March 1976 and continued in Manila 1-5 October 1976. During the first round of consultations the two delegations were unable to reach agreement whereas in October although no definite agreement was reached, the two delegations agreed on an interim agreement for the period 1 October 1976 to 31 December 1977 for the exportation of woven shirts into Norway. The two delegations agreed that further consultations were necessary and that they should be resumed by March 1977.

Another round of consultations took place in Manila 14-18 April 1977. During these deliberations the two delegations agreed that in order to eliminate real risks of market disruption on the Norwegian market for certain textile items and to ensure an orderly development in the exportation of these products from the Philippines, there was a need for an arrangement between the two parties. This arrangement comprises the exports from the Philippines to Norway of woven shirts, men's and boys' wear; woven slacks, jeans and trousers (except shorts), men's and boys' and women's and girls' wear; knitted jackets, jumpers, sweaters, cardigans and pullovers, men's and boys', women's, girls' and infants' wear; and woven blouses, women's and girls' wear. The arrangement includes provisions for carry over (10%), carry forward (7%) and swing (7%). In reaching agreement on this Arrangement the two delegations had regard to the provisions of Article 4 of the Arrangement Regarding International Trade in Textiles in order to ensure the orderly development of trade in textiles between the two countries. The Arrangement covers the period 1 October 1976 to 31 December 1977 for woven shirts, and the year 1977 for the other items. The Arrangement was formally signed on 20 June 1977.

During the consultations the two delegations recognized the very difficult situation for the Norwegian textile and clothing industry due to increased imports at low prices. The mills

affected are partly situated in small communities where their continued existence is vital to the economic life, as well as to the employment, particularly of female workers.

Due to increased imports, the market share of domestic producers has been reduced and was in 1976: shirts 18,7%, blouses 9,7%, slacks, jeans etc. 32,1%, knitted jackets etc. 11,9%.

Please find enclosed a copy of the Arrangement as well as statistics on the Norwegian imports, production and consumption of the products covered by the Arrangement.
