Pursuant to the provisions of paragraph 4 of Article 4 of the Arrangement Regarding International Trade in Textiles, I am instructed by my government to inform the TSB of a series of agreements between the Government of the United States of America and the Government of India to extend on short-term interim bases the bilateral cotton textiles agreement between the two Governments for the period July 1, 1977 through December 31, 1977. The original agreement was notified to the TSB and subsequently circulated to the TC as COM.TEX/SB/46 of December 16, 1974. The original agreement was modified by an exchange of Notes on January 20 and 22, 1976 (notified to TSB and circulated as COM.TEX/SB/158 of May 21, 1976) and was amended by exchanges of Notes of June 13 and 17, 1977 notified to the TSB and circulated to the TC as COM.TEX/SB/264 of September 28, 1977.

In these Note exchanges, the parties to the bilateral agreement agreed: (a) to extend the agreement from October 1, 1976 through October 31, 1977; (b) to extend from October 1, 1976 through November 30, 1977; and, (c) to extend from October 1, 1976 through December 31, 1977. In each case all restraint limits and growth were adjusted pro-rata to the extended periods.

Attached hereto are self-explanatory copies of U.S. State Department Press Releases No. 462 of October 12, 1977, No. 504 of November 7, 1977 and No. 543 of December 5, 1977. The releases give full texts of the Note exchanges which effected the several extensions.

UNITED STATES AND INDIA AMEND TEXTILE AGREEMENT

The United States and India exchanged notes on September 28 and September 29, 1977 respectively, to amend the existing bilateral agreement on trade in cotton textiles between the two countries. The texts of the notes follow:

to October 31, 1977, shall be equal to 108.33 percent of the corresponding limit applicable during the agreement year ending September 30, 1977, plus seven percent of one-twelfth of the corresponding limit for the agreement year ending September 30, 1977.

3. For the agreement year covering the period from October 1, 1976 to October 31, 1977, the consultation levels set in subparagraph 4(b) of the Agreement shall be 108.33 percent of the corresponding levels for the agreement year ending September 30, 1977.

If this proposal is acceptable to the Government of India, this note and Your Excellency's note of acceptance on behalf of your Government shall constitute an agreement between our two Governments, amending the Agreement.
