Pursuant to the provisions of paragraph 4 of Article 4 of the Arrangement Regarding International Trade in Textiles, I am instructed by my Government to inform the TSB of the amendment of the bilateral cotton, wool and man-made fiber textile agreement between the Government of the United States of America and the Government of Malaysia. The original agreement was circulated as COM.TEX/SB/358 of October 3, 1978.

Malaysia has requested permission to exceed consultation levels in categories 317, 613 and 339. The United States has acceded in full to the Malaysian request.

Attached is a copy of State Department Press Release No. 440 of December 5, 1978, setting forth self-explanatory full texts of the exchange of letters giving effect to the amendment.
