Dear Mr. Ambassador,

In connection with the European Economic Community's Agreement on trade in textile products with Argentina negotiated under Article 4 of the Arrangement and initialled on 24.12.1977, I have to inform you of the following :

The imports of wool cloth originating in the Argentina into United Kingdom region of the Community had risen from 8 tons in 1976 to 203 in 1977 and 136 tons (out of an EEC total of 176) being the level at which the Community can ask for a restraint measure in respect of the region of the Community concerned under the provisions of Article 6 of the Agreement.

In particular imports were concentrated in NIMEXE positions 53.11-13, in medium-weight 100 % wool worsted of the serge/flannel plain design affecting a specific sector of industry.

The Community having deemed that there was real risk of market disruption in this case, the two sides held consultations in 26 July 1978 in pursuance of Article 12 of the Agreement.



As a result of these consultations, and in conformity with the provisions of the Agreement, Argentina agreed to limit exports of wool cloth (category 50) to the UK as follows :

Category	Unit	Member State	1978 August 1 December 31	1979	1980	1981	1982
50	tons	UK	105	230	250	270	305

These new limits contained in the agreed minute annexed to this letter (as modified by the attached exchange of Notes), are herewith communicated for information under Article 7 and 8 of the Arrangement.

AGREED MINUTE

In accordance with the request of the Commission, consultations were held on 26 July 1978 between Argentina and the European Economic Community to discuss trade in textiles and in particular trade in wool cloth (category 50) between Argentina and one region of the Community - the United Kingdom.

1. During consultation the Community delegation drew attention to the threat of damage to producers in the United Kingdom market arising from imports of wool cloth originating in the Argentina. Such imports had risen from 8 tons in 1976, to 203 in 1977 and 136 tons (out of an EEC total of 176) in the first five months of 1978. In particular imports were concentrated in NIMEXE positions 53.11-13, in medium-weight 100 % wool worsted of the serge / flannel plain design, affecting a specific sector of industry.
2. The Argentina delegation emphasised that, in its view, trade at such level could not produce the results feared, and that no major expansion of exports was envisaged.

3. Nevertheless in a spirit of cooperation Argentina agreed to limit exports of wool cloth (category 50 of the bilateral agreement initiated between Argentina and the Community on December 1977 ) to the United Kingdom as follows :

August 1. - December 31. 1978	60 tons ( 50 )
1979	245 tons
1980	265 tons
1981	285 tons
1982	305 tons

Such exports would be subject with effect from August 1. 1978, to the double-checking procedures specified in the bilateral Agreement and to such other of its provisions as were relevant.

La Mission de la République d'Argentine auprès des Communautés Européennes présente ses compliments à la Direction Générale des Relations Extérieures de la Commission des Communautés Européennes et a l'honneur de se référer à l'Acte d'Accord sur les exportations argentines de tissus de laine (catégorie 50) au Royaume-Uni, qui a été signé le 3 août 1978.

La Mission de la République d'Argentine désire manifester qu'antérieurement à la conclusion de l'Acte d'accord mentionné, il existait au pouvoir des exportateurs argentins, des cartes de crédit couvrant l'exportation au Royaume-Uni de 105 tonnes de tissus de laine (catégorie 50) à être embarquées durant l'année 1978. A ce moment, ce fait n'était pas connu des autorités argentines, étant donné que la rapidité avec laquelle l'Accord mentionné a été conclu, empêcha de réaliser parmi les entreprises exportatrices, un relevé minutieux des contrats en cours d'exécution.

La Mission de la République d'Argentine, considérant la nature d'obligation pour les exportateurs argentins, en ce qui concerne les compromis existants, et le dommage qui pourrait surgir de ne pas les honorer, demande que la limite des exportations de tissus de laine (catégorie 50) soit fixée à 60 tonnes pour la période allant du 1er août au 31 décembre 1978; soit portée à 105 tonnes. Les 45 tonnes supplémentaires pourraient être déduites, en parts égales, des limites accordées pour les années 1979, 1980 et 1981. En conséquence, les quantités mentionnées au point 3 de l'Acte d'Accord mentionné du 3 août 1978, seraient modifiées de la manière suivante :

- 1er août - 31 décembre 1978	105 tonnes
- 1979	230 "
- 1980	250 "
- 1981	270 "
- 1982	305 "

La Mission de la République d'Argentine auprès des Communautés Européennes saisit cette occasion pour renouveler à la Direction Générale des Relations Extérieures de la Commission des Communautés Européennes, l'assurance de sa plus haute considération.
