Dear Mr Ambassador,

This is to inform you that an informal understanding has been reached between India and Sweden on a provisional prolongation of that part of their previous agreement on trade in textiles which expired on February 28, 1979 (see document COM.TEX/SB/371). The prolongation has been agreed for a four months period ending June 30, 1979. The reason for this are heavy negotiation schedules and difficulties to find an early date for consultations, which would suit both parties. The levels of the agreement will be applied on a pro rata basis during this period.

When a definite agreement to supersede the provisional prolongation has been concluded, you will of course be notified accordingly.
