a) Paragraph 1, unnumbered sub-paragraph 2:

- The date of the Turkish import list has to be changed as 1979.
- ^s The date of the Turkish official Gazette where the import list for 1979 was published is 27 January 1979.

b) Paragraph 2, unnumbered sub-paragraph 2:

- In the first sentence where countries with which Turkey has bilateral arrangements are indicated, Bulgaria, Poland, Arab Republic of Egypt, Czechoslovakia, should be deleted.
- Second part of the same sub-paragraph in the parenthesis should be deleted fully.
