Dear Mr. Ambassador,

With reference to your letter of 10 July 1979, Ref. TS/140-1, my authorities instructed me to inform you that Austria made a full notification of the restrictions applied to textile products covered by the MFA on 1 March 1974 (Ref.No. 1220-A/74). Since that date Austria kept the Textiles Surveillance Body informed of all the bilateral agreements it had to conclude with countries exporters of textiles. In these notifications the reasons for as well as the justification of these agreements where given in every detail.

These notifications have kept their full value; they should therefore provide the adequate basis for the review to be carried out by the TSB in accordance with Article XI:11.
