Record of Understanding

During the period January 1, 1979, to December 31, 1979, the Government of Sweden will admit imports, through a system of import licences, for deliveries from Mauritius to Sweden of products of Mauritius origin listed in Annex I to this Record of Understanding, up to the levels stated in Annex II to this Record. It is understood that imported quantities which are re-exported are not to be debited to this amount.

The Government of Mauritius and the Government of Sweden agree to consult each other, at the request of either, when any problem arises from the implementation of this agreement. The Government of Mauritius and the Government of Sweden agree furthermore to enter into consultations, through diplomatic channels, on the prolongation, modification or termination of this agreement before the end of the period of agreement.
