Dear Mr. Chairman:

Pursuant to the provisions of paragraph 4 of Article 4 of the Arrangement Regarding International Trade in Textiles, I am instructed by my government to inform the TSB of amendments of the bilateral cotton, wool and man-made fiber textile agreement between the Government of the United States of America and the Government of Pakistan. The basic agreement was notified to the TSB on February 27, 1978, and circulated as COM.TEX/SB/300.

These amendments established new and increased consultation levels for several Categories in the first and second agreement years (1978 and 1979). The amendments also change for the second agreement year Category 315 (cotton printcloth) from a designated consultation category with a 1978 level of 26,049,000 SYE to a specific limit with a 1979 level of of 33,500,000 SYE; change Category 341 (cotton blouses) from a minimum consultation category with a 1978 level of 700,000 SYE to a specific limit with a 1979 level of 2,000,000 SYE; and modify the specific limits for Categories 313 (cotton sheeting); 319 (cotton duck) and 363 (cotton towels).

Attached hereto are copies of the Notes giving effect to these amendments.

UNITED STATES AND PAKISTAN AMEND TEXTILE AGREEMENT

The United States and Pakistan exchanged notes on December 7, 1978 and July 25, 1979, to amend the existing bilateral agreement on trade in cotton textiles and textile products between the two countries. The texts of the notes follow:

UNITED STATES NOTE

December 7, 1978

Sir:

I refer to the Arrangement Regarding International Trade in Textiles (the "Arrangement"), done at Geneva on December 20, 1973, and extended by protocol opened for signature at Geneva on December 15, 1977, and to the agreement of January 4 and 9, 1978 (the "Agreement") between the Government of Pakistan and the Government of the United States of America, concerning trade in cotton textiles and textile products.

I also refer to discussions between representatives of the Government of Pakistan and the Government of the United States of America in Washington on October 23, 1978, concerning exports to the United States of America of certain cotton fiber textiles and textile products from Pakistan. As a result of these discussions I propose, on behalf of the Government of the United States of America, that during the first Agreement Year exports from Pakistan to the United States of America of the following categories shall not exceed the consultation levels stated below:

I also propose that Annex A of the Agreement be corrected by deleting the term "Category 340" and substituting therefor the term "Category 341".

If this proposal is acceptable to the Government of Pakistan, this note and your note of confirmation on behalf of the Government of Pakistan shall constitute an amendment to the Agreement effective on the date of your note of confirmation.

I refer to the Agreement concerning trade in cotton textiles of January 4, 1978, as amended, between the United States and Pakistan (hereinafter referred to as the Agreement) and to recent discussions between Representatives of our two Governments concerning exports of cotton textiles from Pakistan to the United States. As a result of those discussions, I wish to propose the following amendment relating to trade in cotton textiles between Pakistan and the United States.

1) I propose on behalf of my Government the following new consultation levels for the 1979 agreement year:

369	19,000,000

2) Paragraph 5 of the Agreement is amended to establish new specific limits beginning in the 1979 agreement year as follows:

If the foregoing proposal is acceptable to the Government of Pakistan, this note and your note of confirmation on behalf of the Government of Pakistan shall constitute an agreement amending the Agreement.
