Dear Mr. Chairman:

This responds to the request during yesterday's discussion of the new United States-Japanese bilateral textile agreement for earlier restraint or trade levels for those categories which, under the consultation provisions of that agreement, the Japanese Government has agreed will not exceed agreed-upon limits. The equivalent import or restraint levels for CY-1978 are as follows:
