Dear Mr. Chairman:

Pursuant to the provisions of paragraph 4 of Article 4 of the Arrangement Regarding International Trade in Textiles, I am instructed by my government to inform the Textiles Surveillance Body of further amendments of the cotton, wool and man-made fiber textile agreement between the Government of the United States of America and the Government of India. The original bilateral agreement and prior amendments have been notified and circulated as COM./TEX/SB/315, 340, 356, 394, 439 and 462.

These amendments increase the consultation levels for Category 666 from 900,000 to 4,000,000 square yards equivalent (SYE) and the consultation level for Category 636 from 700,000 to 1,100,000 SYE.

UNITED STATES AND INDIA AMEND TEXTILE AGREEMENT

The United States and India exchanged letters dated October 26, 1979 and November 6, 1979 and exchanged notes dated November 6, 1979 to amend the existing bilateral textile agreement. The texts of the letters and notes follow:

INDIA LETTER

October 26, 1979

Department of State Washington, D.C.

The Embassy of India in the United States presents its compliments to the U.S. Department of State and has the honour to refer to the Agreement concerning exports to the United States of cotton, wool and man-made fibre textiles and textile products manufactured in India affected by exchange of letters between the two governments on December 30, 1977, as amended.

Under the provisions of paragraph 6 of the above mentioned Agreement, the Government of India informs the Government of the United States that it wishes to export to the United States textile products in excess of the consultation level currently applicable to category 666, other furnishings of man-made fibre. Accordingly, the Embassy has the honour to request that the consultation level for category 666 be raised to 4 million square yards equivalent for the Second Agreement Year.

The Embassy of India avails itself of this opportunity to renew to the U.S. Department of State the assurances of its highest consideration.
