I am instructed by my government to inform the TSB that the restriction imposed on imports of Category 604 (spun plied acrylic yarn - TSUSA 310.5049) from the Republic of South Africa was terminated on 31 December 1979. The restriction, which was notified and circulated as COM./TEX/SB/402, was in effect for the one-year period, January 1 - December 31, 1979.
