Pursuant to the provisions of paragraph 4 of Article 4 of the Arrangement Regarding International Trade in Textiles, I am instructed by my government to inform the Textiles Surveillance Body of the further amendment of the cotton, wool and man-made fiber textile agreements between the Government of the United States of America, on the one hand, and the Governments of Columbia; Singapore and Thailand on the other. The original bilateral agreements and prior amendments have been notified and circulated as follows: Columbia, COM.TEX/SB/410 and 436; Singapore, COM.TEX/SB/399, 400, 464 and 495; and Thailand, COM.TEX/SB/411, 412, 473 and 496.

Each of these amendments effect requests for increases in consultation levels for the countries concerned.

Attached hereto are copies of the notes given effect to these amendments.
