Dear Ambassador Wurth,

In response to your letter of 18 April inviting the submission of information from participating countries on restrictions introduced or maintained by them since 1 January 1978, I wish to inform you that Hong Kong maintains no restrictions on trade in textiles except on exports covered by bilateral agreements entered into between Hong Kong and certain importing countries under the provisions of the MFA. Those bilateral agreements have all been notified to the TSB and circulated to the Textiles Committee in the following documents :
