UPDATING OF THE LISTING OF NOTIFICATION OBLIGATIONS AND THE COMPLIANCE THEREWITH AS SET OUT IN ANNEX III OF THE REPORT OF THE WORKING GROUP ON NOTIFICATION OBLIGATIONS AND PROCEDURES

Corrigendum

In document G/L/223/Rev.24, the tables on pages 24-31; 34-37; 38-41; 42-44; and 55-58 should read as set out below.

Corrections appear in the body of the relevant tables below and are indicated in **boldface** type. They refer to information omitted from document G/L/223/Rev.24 and correspond to the following sections: the Agreement on Implementation of Article VI of the GATT 1994 (Anti-Dumping Agreement); the Agreement on Subsidies and Countervailing Measures (SCM); the Understanding on the Interpretation of Article XVII of the GATT 1994 (State Trading Enterprises); the Agreement on the Implementation of Article VII of the GATT 1994 (Customs Valuation); the Agreement on Import Licensing Procedures; the Agreement on Trade-Related Investment Measures (TRIMs); and the Agreement on Technical Barriers to Trade (TBT). Please note that the corrections correspond to the period 1 January to 31 December 2016, except in the case of the Anti-Dumping Agreement, the SCM Agreement, and State Trading Enterprises, which correspond to the period 1 January to 30 June 2016.

With regard to the Agreement on the Implementation of Article VII of the GATT 1994 (Customs Valuation) and the Agreement on Import Licensing Procedures, the notifications received from Kazakhstan, indicated in the tables on page 14 below, correspond to the relevant part of the tables that, in the original document, are found on pages 38-41 and 42-44 respectively.

In addition, the explanatory note concerning the TBT Agreement, which appears on page 9 of document G/L/223/Rev.24, should now read as follows:

14 AGREEMENT ON TECHNICAL BARRIERS TO TRADE

- 14.1. All Members are required to notify on a "one-time" basis "measures in existence or taken to ensure the implementation and administration of this Agreement" (Article 15.2). Members that have accepted the Code of Good Practice (Annex C of the TBT Agreement) should notify this to the WTO through ISO. Notifications of acceptance and information on Standards Bodies work programmes can be found on the WTO ISO Standards Information Gateway (https://tbtcode.iso.org)
- 14.2. The TBT Information Management System (http://tbtims.wto.org) contains all notifications submitted by Members to the WTO, including those under Art. 10.6, 15.2, 10.7 and Annex 3. The notification alert system (http://www.ePingalert.org) allows Members and stakeholders to keep track of notifications of technical regulations and conformity assessment procedures which may be of interest to their market.
- 14.3. Members are encouraged to use the TBT Notification Submission System (TBTNSS) when notifying draft technical regulations and conformity assessment procedures to the WTO. Further details can be obtained by email (tbtnss@wto.org).
