#### ACTIVITIES DEVELOPED ON SANITARY AND PHYTOSANITARY (SPS) RELATED ISSUES

#### Communication from the Inter-American Development Bank (IDB)

The following communication, received on 9 February 2011, is being circulated at the request of the <u>IDB</u>.

#### I. CAPACITY BUILDING ON SPS RELATED ISSUES

A. DEMAND-DRIVEN CAPACITY BUILDING

1. The Integration and Trade Sector (INT) has implemented capacity building activities for the Latin America and the Caribbean (LAC) government officials and private sector on SPS related issues. The objectives of these activities are: (i) to strengthen the Latin America and the Caribbean (LAC) capacity to address SPS related challenges and, (ii) to foster the technical knowledge on SPS related requirements to access specific markets.

**Beneficiaries:** The target audiences are government officials from the ministries of Agriculture, Trade and Health; SPS Agencies; Export Promotion Agencies; and the private sector from LAC countries.

**Methodology:** These capacity building activities are organized based on a demand-driven approach. They aim at delivering training courses according to the specific needs raised by a particular country or region. They are derived from client-driven needs with a short to medium term scope, and are rapid responses to demands emerging directly from the clients. The topics covered vary depending on the specific needs of the country or region where it will take place. These trainings are provided by INT experts, with the collaboration of other donors (FDA, USDA/APHIS, European Commission), international (WTO), regional (SIECA, IICA, OIRSA) and local (National Export Promotion Agencies, Chamber of Commerce) institutions.

2. The most recent SPS trainings implemented and in pipeline are as follows:

- Β. SUPPLY-DRIVEN CAPACITY BUILDINGS
- (a) IDB/INTAL-WTO Capacity Building Programme

The IDB, jointly with the WTO, has developed a Training Programme for trade negotiators in 3. the framework of the Memorandum of Understanding signed by these institutions in February 2002. These trainings aim to strength the understanding and implementation of the WTO legal framework. Every year technical training is delivered on Agriculture Trade, SPS and/or TBT, and other subjects.

Beneficiaries: The training programme is directed to national government officials from Latin America and the Caribbean (LAC) whose working responsibilities are closely related to the process of trade negotiation at a multilateral level.

Methodology: Annually the list of courses and the agenda are designed jointly by the Division of Technical Cooperation of the WTO and the IDB. The content of the courses vary depending on the negotiation process dynamics related to the Doha Development Agenda and the specific needs of the countries of the region. The trainings are provided by INT and WTO experts, with the collaboration of national and regional institutions. # II. SPS DATABASE

5. The Integration and Trade Sector (INT) has developed a database (INTradeBID) that provides access to accurate and updated information about trade agreements, market access, trade statistics and indicators. It includes a set of applications that facilitates the understanding, analysis and implementation of trade agreements. It contains a specific module on sanitary and phytosanitary measures (SPS), which provides information on:

- (i) SPS related commitments negotiated in the regional trade agreements;
- (ii) Specific Trade Concerns raised before the WTO SPS Committee;
- (iii) Private standards;
- (iv) Import refusals by the United States and European Union due to the lack of compliance with SPS related requirements;
- (v) SPS related requirements to export agricultural products to some specific countries.
