SPS-RELATED TECHNICAL ASSISTANCE PROVIDED BY THE EUROPEAN UNION IN 2012

COMMUNICATION FROM THE EUROPEAN UNION

Addendum

The following communication, received on 14 March 2013, is being circulated at the request of the Delegation of the <u>European Union</u>.

Overview

The European Union (EU) is the world's foremost advocate – and biggest source – of technical assistance. This assistance takes the form of both development aid and aid directed at improving opportunities for trade. It is specifically targeted at helping developing countries enhance their ability and capacity to trade in a broad range of areas, including those with direct relevance to the sanitary and phytosanitary (SPS) field.

During 2012, the total value of SPS-related technical assistance provided by the EU and its member States amounted to approximately **78 million Euro**. This covered more than 200 SPS-related projects or activities that were completed, or were still on-going, during the course of 2012, in close to 100 countries.

- 1.1. In response to the Secretariat request in document G/SPS/W/101, the European Union hereby submits information on technical assistance provided to other countries during 2012, in accordance with Article 9 of the Agreement on the Application of Sanitary and Phytosanitary Measures.
- 1.2. SPS-related technical assistance is provided primarily to facilitate exports from developing countries often with a special focus on small producers in order to encourage access to the EU and other world markets. The assistance is also geared towards improving governance and meeting international standards, both of which help countries to take better advantage of the trade opportunities that are available.
- 1.3. EU assistance in the SPS-field is therefore largely aimed at transferring technical know-how, giving practical assistance in the field, and helping to build governance frameworks and appropriate infrastructure. In so doing, EU technical assistance projects address all four of the categories listed in the Secretariat document G/SPS/GEN/206, namely: information; training; "soft" and "hard" infrastructure development.
- 1.4. The technical assistance activities, highlighted in the attached table, were provided by the European Commission and individual EU member States. These activities took place at the bilateral, regional or multilateral level, through own initiatives, the Standards and Trade Development Facility (STDF) or the International Standard Setting Bodies (ISSBs), better known as the *Three Sisters*.

- 1.5. Within the European Commission, different components are involved in the provision of technical assistance. They are primarily: the Directorate General for Development and Cooperation, the Directorate General for Enlargement, the Directorate General for Trade and the Directorate General for Health and Consumers. In member States, Ministries dealing with agriculture, health and/or related disciplines, or development agencies, lead the efforts in this field.
- 1.6. EU projects can be broadly divided into two main fields: those that seek to develop SPS standards and those that seek to ensure the proper application of SPS standards.
- 1.7. In its thrust to develop SPS standards, the European Commission under its Aid for Trade programme contributes significantly to the work of the *Three Sisters*. In total, over the period 2011-2014, EUR 4.3 million is being granted, via multiannual contribution agreements, to:
 - facilitate the participation of developing countries in meetings of the ISSBs;
 - establish and maintain the International Plant Protection Convention's (IPPC)
 Implementation Review and Support System (IRSS);
 - help the Codex Alimentarius' Trust Fund;
 - assist Codex Alimentarius to perform a pilot study on mycotoxins;
 - help the World Organization for Animal Health (OIE) organise global conferences in the areas of animal health, animal welfare and veterinary public health.
- 1.8. When it comes to applying SPS standards, some of the main EU projects which seek to support the application of standards, are the following:
 - a. PIP (Phase II) Quality and Conformity Fruits and Vegetables Programme

PIP is a cooperation programme amounting to EUR 33 million managed by COLEACP (the Europe-ACP Liaison Committee). The programme aims to support producers of fruit and vegetables to comply with European SPS regulations, and in so doing, improve trade of agricultural products. It is financed by the European Development Fund and implemented at the request of the ACP (Africa, Caribbean and Pacific) Group of States. The second stage of PIP was launched in October 2009 – following a successful first phase which started in 2001 – and will run for a total period of 5 years.

b. **VET-GOV** – Reinforcement of African Veterinary Governance

This programme aims to improve the institutional environment in most African countries for the provision of affordable, accessible and sustainable quality veterinary services by improving aspects of governance and institutional reforms. Its primary strategic goal is to strengthen veterinary services at the national level, to encourage regional institutions to fulfil their roles related to coordination, to harmonise standards in line with the One World One Health (OWOH) concept and to support countries to provide the right environment for public and private investment. The total budget of the project amounts to EUR 30 million for the period 2011-2016.

c. **EDES** – Development of Food Safety Systems Programme

COLEACP, in cooperation with a consortium of European food safety agencies, has been entrusted by the European Union with the implementation of the EDES Programme which seeks to improve the contribution of food and feed trade to poverty reduction in beneficiary countries. The project's purpose is to ensure that risk-based food and feed safety systems for export products are established in ACP countries and are in line with regional, international and EU SPS standards. Launched at the request of the ACP Group of States, it has received funding worth EUR 29.5 million from the European Development Fund covering 2010-2014.

d. **PRACAMS** – Support Program for the Creation of a Regional System of Quality and the Application of Sanitary and Phytosanitary Measures in Central America

PRACAMS promotes the creation of a regional quality system and the application of sanitary and phytosanitary measures, to ensure compliance by Central American

economies with the requirements of international markets under the TBT and SPS Agreements of the WTO. The Commission has made a contribution of EUR 23.5 million which will run from the end of 2010 until 2016.

e. **PAN SPSO** (Phase II) - Participation of African Nations in Sanitary and Phytosanitary Standard Setting Organisations

PAN SPSO has the overall objective of contributing to poverty reduction by promoting international trade of agricultural products in Africa. Its specific objective is to strengthen and sustain the effective participation of African countries during the formulation of international standards by the OIE, IPPC and Codex on animal health, plant health and food safety. Now in its second phase, the Commission has made a contribution of EUR 2 million which will run from the beginning of 2012 until the end of 2014.

f. **BTSF** – Better Training for Safer Food

Better Training for Safer Food is a European Commission training initiative covering food and feed law, animal health and welfare and plant health rules. It trains staff from member States and candidate countries who are involved in official controls. The aim is to keep participants fully adjourned of EU regulations in these areas and to ensure more harmonised and efficient controls. Efficient controls are an essential factor in maintaining high levels of consumer protection, animal health and plant health. Harmonisation of controls should help to create a level playing field for food businesses. Training is also organised specifically for third, particularly developing, country participants so as to familiarise them with EU requirements. This is also aimed at easing access to the EU market for products from developing countries. The total budget for training in non-EU countries, in 2011-2012, amounted to EUR 5.1 million.

g. Twinning Pre-EU accession instrument (IPA)

One of the great challenges for the countries aspiring to join the European Union, is to reform, strengthen and adapt their public institutions to EU standards, so that they can provide a better service to their citizens, correctly apply EU rules and benefit fully from EU membership. To meet this need, the European Union provides focused assistance through its Twinning programme. Launched in May 1998, Twinning is now one of the principal tools of "institution building" in enlargement countries. The success and effectiveness of the instrument was recognised in 2003 when Twinning was extended to cover not only candidates to EU membership, but also countries in the EU neighbourhood, namely in Eastern Europe and the Mediterranean region. So far the European Union has invested over EUR 1.5 billion in more than 1500 projects in 21 countries under this programme.

h. The TAIEX instrument – Technical Assistance and Information Exchange

Established in 1996, over the last 16 years the TAIEX instrument of the European Commission has evolved and expanded its mandate. In 2006, TAIEX's original scope in candidate countries and potential candidates was extended to the neighbourhood countries. TAIEX shares EU member State administrations' technical expertise in all fields of EU legislation (the so-called EU "acquis") with beneficiaries. Today, TAIEX has become an integral part of the Enlargement Policy, and every year is responsible for organising nearly 1,900 short term technical assistance operations. Every year an average of EUR 15 million is committed under this instrument.

- 1.9. These few, selected projects show the breadth and depth of EU funded technical assistance.
- 1.10. One can see that all SPS-related fields are covered through the various actions taking place across the globe. Other projects, found in the annex, also attest to this fact.
- 1.11. The activities, in the annexes, have been categorised by subject matter for ease of reference.

- 1.12. The European Union would like to draw attention to its reports of previous years as found in documents G/SPS/GEN/1139 of 13 March 2012 and G/SPS/GEN/1074 of 18 March 2011 identifying the technical assistance provided by the European Union during 2011 and 2010.
- 1.13. Any non-EU country requiring SPS-related technical assistance is invited to approach the EU delegation based in their country, or the relevant directorates of the European Commission located in Brussels, Belgium or individual EU member States for further information.
