## SPS-RELATED TECHNICAL ASSISTANCE PROVIDED BY THE EUROPEAN UNION IN 2013

#### COMMUNICATION FROM THE EUROPEAN UNION

#### Addendum

The following communication, received on 13 March 2014, is being circulated at the request of the Delegation of the <u>European Union</u>.

#### Overview

The European Union (EU) preserved its commitment to provide technical assistance to third countries in 2013 despite the global economic downturn. The aim of the assistance provided was to facilitate and enhance developing countries' ability to bring their products to market and to take better advantage of the opportunities to trade around the world.

In the sanitary and phytosanitary (SPS) field alone, in 2013, the EU's contribution amounted to approximately **EUR 75 million** and was provided jointly by the European Commission and member States. More than 300 SPS-related projects were financed worldwide.

EU assistance takes the form of both development assistance and aid directed at improving opportunities for trade. As the world's largest importer of products from developing countries, the European Union is pleased to provide this assistance ensuring that it is mutually beneficial in terms of securing new markets for developing countries and finding supplies of safe food for the European Union.

- 1.1. In response to the Secretariat's request in document G/SPS/W/101, the European Union hereby submits information on technical assistance provided to other countries during 2013, in accordance with Article 9 of the Agreement on the Application of Sanitary and Phytosanitary Measures
- 1.2. SPS-related technical assistance is provided primarily to facilitate exports from developing countries often with a special focus on small producers in order to encourage access to the European Union and other world markets. The assistance is also geared towards improving governance and meeting international standards, both of which help countries to take better advantage of available trade opportunities.
- 1.3. The technical assistance activities, listed in the attached table, are provided by the European Commission and individual EU member States. These activities took place at a bilateral, regional or multilateral level, through own initiatives, in conjunction with the Standards and Trade Development Facility (STDF) or under the framework of the three sisters: Codex, IPPC and OIE.
- 1.4. Within the European Commission, different services are involved in the provision of SPS-related technical assistance. They are: the Directorate General for Development and Co-operation, the Directorate General for Enlargement, the Directorate General for Trade and the Directorate

General for Health and Consumers. In member States, ministries dealing with agriculture, health and/or related disciplines, or development agencies, lead the efforts in this field.

- 1.5. The European Union is also committed to meet the requirements of the latest WTO Agreement on Trade Facilitation, agreed at the 9<sup>th</sup> WTO Ministerial Conference. The European Union looks forward to submitting relevant trade facilitation information in connection with its technical assistance activities in the SPS field in the forthcoming period.
- 1.6. In 2013, the SPS-related projects undertaken can be broadly divided into two main fields: those that seek to contribute to the development of SPS standards and those that seek to ensure their proper application.
- 1.7. In its thrust to contribute to the development of SPS standards, the European Union under its Aid for Trade programme contributes significantly to the work of the three sisters. In total, over the period 2011-2014, EUR 4.3 million is being granted, via multiannual contribution agreements, to:
  - facilitate the participation of developing countries in meetings of the international standard-setting bodies (ISSBs);
  - establish and maintain the International Plant Protection Convention's Implementation Review and Support System;
  - help the World Organisation for Animal Health organise Global Conferences in the areas of animal health, animal welfare and veterinary public health;
  - assist Codex Alimentarius to perform a pilot study on mycotoxins in sorghum in certain African countries (January 2012 - December 2014); and
  - contribute to the Codex Alimentarius' Trust Fund.
- 1.8. When it comes to the application of SPS standards, some of the main EU projects which provide this support, are the following:
  - a. **PIP** (Phase II) Quality and Conformity Fruits and Vegetables Programme

PIP is a cooperation programme amounting to EUR 33 million, supported by the European Commission and managed by COLEACP (the Europe-ACP Liaison Committee). The programme aims to support producers of fruit and vegetables to comply with European SPS regulations, and in so doing, to improve the trade of agricultural products. It is financed by the European Development Fund and implemented at the request of the ACP (Africa, Caribbean and Pacific) Group of States. The second stage of PIP was launched in October 2009 – following a successful first phase which started in 2001 – and will run until the end of 2015.

b. **VET-GOV** – Reinforcement of African Veterinary Governance

The VET-GOV programme aims to improve the institutional environment in most African countries in order to create affordable, accessible and sustainable quality veterinary services. The strategic goal of the programme is to institutionally strengthen the veterinary services at national level, and also to strengthen regional institutions to play their roles of coordination and harmonisation in line with the "One World One Health" initiative. It also aims at supporting countries to enable an appropriate environment for public and private investment. The total budget of the project amounts to EUR 30 million for the period 2011-2016.

c. **EDES** – Development of Food Safety Systems Programme

The EDES Programme is supported by the European Commission, and managed and implemented by a Consortium led by COLEACP, in cooperation with a consortium of European Food Safety Agencies, which has been entrusted by the European Union to implement the programme. It seeks to improve the contribution of food and feed trade to poverty reduction in ACP beneficiary countries. The purpose of the project is to ensure that risk-based food and feed safety systems for export products are established in line with regional, international and EU SPS standards. With the methodological support and expertise of the Consortium's partners, EDES develops capacity building activities, mainly through training, technical assistance, facilitation or coaching. Launched at the

request of the ACP Group of States, it has received funding worth EUR 29.5 million from the European Development Fund covering 2010-2014.

d. **PRACAMS** – Support Programme for the Creation of a Regional System of Quality and the Application of Sanitary and Phytosanitary Measures in Central America

PRACAMS aims to promote the creation of a Regional Quality System and the application of sanitary and phytosanitary measures to ensure compliance by Central American economies with the requirements of international markets as provided for under the WTO TBT and SPS Agreements. The Commission has made a contribution of EUR 23.5 million to the Programme, which will run from 2010 until 2016.

e. BTSF – Better Training for Safer Food

Better Training for Safer Food is a European Commission training initiative covering food and feed law, animal health and welfare, and plant health rules. It trains staff from member States and EU candidate countries who are involved in official controls. The aim is to keep participants fully abreast of EU regulations and to ensure more harmonised and efficient controls. Efficient controls are an essential factor in maintaining high levels of consumer protection, animal health and plant health. Harmonisation of controls should help to create a level playing field for food businesses. Training is also organised specifically for third, particularly developing, country participants so as to familiarise them with EU requirements. This is also aimed at easing access to the EU market for products from developing countries. The total budget for training in non-EU countries, as of 2013 amounts to EUR 8.5 million. It includes two major new programmes:

- BTSF-ISSBs which aims at providing the capacity to non-EU countries to participate more effectively in the work of the three sisters i.e. Codex, the OIE and the IPPC.
- BTSF-World which is a global training programme covering three geographical areas (Africa and European Neighbourhood Policy countries; Asia and Pacific States; Latin America and the Caribbean States) and addressing food safety, plant health, animal health and welfare. Trainings consist of either regional workshops or assistance missions that are intended to provide for a rapid response concerning trade-related problems.
- f. **TRACES** Trainings related to the Trade Control and Expert System

TRACES is the health certification system established by the European Commission in 2005 to facilitate safe trade within the EU single market and in relation to imports of live animals and animal products by providing full traceability. Compulsory for all EU member States, in 2008, TRACES was opened to third countries exporting to the European Union - for use on a voluntary basis. Following the organisation of training courses in numerous trading partners of the European Union, 45 non-EU countries are currently using TRACES for the certification of their exports of live animals or products to the European Union. In 2013, training was provided to 6 third countries - 4 of which are now using TRACES.

## g. One Health Programme in Asia

The One Health Programme in Asia is aimed at further strengthening and institutionalising the collaboration between the animal and human health sectors and to support identifying the relevant issues and drivers at the ecosystem or environmental health interface. The programme is designed to improve health and well-being in populations in Asia by tackling the main health risks and challenges. The programme aims to strengthen capacities in order to address risks related to infectious diseases via the promotion of innovative and regional cross—sectoral and multi-actor collaborations and networking through the implementation of the One Health approach. The total budget is approximately EUR 8 million.

h. **PAN SPSO** (Phase II) - Participation of African Nations in Sanitary and Phytosanitary Standard Setting Organisations

PAN SPSO has the overall objective of contributing to poverty reduction by promoting international trade of agricultural products in Africa. Its specific objective is to strengthen and sustain the effective participation of African countries during the

formulation of international standards by the OIE, IPPC and Codex. Now in its second phase, which will run from the beginning of 2012 until the end of 2014, the European Commission has made a contribution amounting to EUR 2 million.

### i. Twinning Pre-EU accession instrument (IPA)

One of the great challenges for the countries aspiring to join the European Union is to reform, strengthen and adapt their public institutions to EU standards. To meet this need, the European Union provides focused assistance through its Twinning programme. Launched in May 1998, Twinning is now one of the principal tools of "institution building" in enlargement countries. The success and effectiveness of the instrument was recognised in 2003 when the Twinning was extended to cover not only candidates to EU membership, but also countries in the EU neighbourhood, namely in Eastern Europe and the Mediterranean region. So far the European Union has invested over EUR 1.5 billion in more than 1500 projects in 21 countries under this programme, in all areas.

#### j. TAIEX instrument – Technical Assistance and Information Exchange

Established in 1996, over the last 17 years the TAIEX instrument of the European Commission has evolved and expanded its mandate. In 2006, TAIEX's original scope in candidate countries and potential candidates was extended to the Neighbourhood countries. TAIEX shares member State administrations' technical expertise in all fields of EU legislation (the so-called EU acquis) with beneficiaries. Today, TAIEX has become an integral part of the Enlargement Policy and every year, is responsible for organising nearly 1,900 short term technical assistance operations. An average of EUR 15 million is committed under this instrument annually.

- 1.9. The European Union would like to draw attention to its reports of previous years as found in documents G/SPS/GEN/1139/Add.1 of 15 March 2013, G/SPS/GEN/1139 of 13 March 2012 and G/SPS/GEN/1074 of 18 March 2011 identifying the technical assistance provided between 2010 and 2012.
- 1.10. Any non-EU country requiring SPS-related technical assistance is invited to approach the EU Delegation based in their country, or the relevant directorates of the European Commission located in Brussels, Belgium or individual EU member States for further information.
