COMMUNICATION FROM THE EUROPEAN UNION

*Addendum*

The following communication, received on 12 March 2015, is being circulated at the request of the Delegation of the European Union.

**Overview**

The European Union (EU) continued to provide SPS-related technical assistance to non-EU countries during 2014. The aim of the assistance provided was to facilitate and enhance developing countries' ability to bring their products to market and to take better advantage of the opportunities to trade around the world.

The EU's technical assistance activities referred to in this note focus on the SPS area or cover a broader scope. In 2014, more than 360 such projects were financed worldwide. The EU's total contribution in 2014 amounted to approximately **EUR 152 million**<sup>1</sup> and was provided jointly by the European Commission and EU member States.

EU technical assistance takes the form of both development assistance and aid directed at improving opportunities for trade. As the world's largest importer of products from developing countries, the European Union's assistance is mutually beneficial in terms of securing new markets for developing countries and supplies of safe food for the European Union.

1.1. In response to the Secretariat's request in document G/SPS/W/101, the European Union hereby submits information on technical assistance provided to other countries during 2014, in accordance with Article 9 of the Agreement on the Application of Sanitary and Phytosanitary Measures. focus

1.2. SPS-related technical assistance is provided primarily to facilitate exports from developing countries – often with a special focus on small producers – in order to encourage access to the European Union and other world markets. The assistance is also geared towards improving governance and meeting international standards, both of which help countries to take better advantage of available trade opportunities.

1.3. The technical assistance activities, listed in the attached table, are provided by the European Commission and individual EU member States. These activities take place at a bilateral, regional or multilateral level, through own initiatives, in conjunction with the Standards and Trade Development Facility (STDF) or under the framework of the three sisters: Codex, IPPC and OIE.

1.4. Within the European Commission, different services are involved in the provision of SPS-related technical assistance. They are: the Directorate General for International Cooperation and Development, the Directorate General for Neighbourhood and Enlargement Negotiations, the Directorate General for Trade and the Directorate General for Health and Food Safety. In EU member States, ministries dealing with agriculture, health and/or related disciplines, or development agencies, lead the efforts in this field.

1.5. The SPS-related projects undertaken can be broadly divided into two main fields: those that seek to contribute to the development of SPS standards and those that seek to ensure their proper application.

1.6. In its thrust to help with the development of SPS standards, the European Union – under its Aid for Trade programme – contributes significantly to the work of the three sisters. In total, over the period 2011-2014, EUR 4.3 million was granted, via multiannual contribution agreements, to:

- facilitate the participation of developing countries in meetings of the international standard-setting bodies (ISSBs);
- establish and maintain the International Plant Protection Convention's Implementation Review and Support System;
- help the World Organisation for Animal Health organise Global Conferences in the areas of animal health, animal welfare and veterinary public health;
- assist Codex Alimentarius to perform a pilot study on mycotoxins in sorghum in certain African countries (January 2012 - December 2014); and
- contribute to the Codex Alimentarius' Trust Fund.

1.7. Two main EU projects, Quality and Conformity Fruits and Vegetables Programme (PIP) and Development of Food Safety Systems Programme (EDES), which will end in 2015, have undergone mid-term external evaluations in 2013, which is a standard procedure for all programmes funded by the European Union. The aim of the mid-term reviews was both to check the progress of the programmes, and to produce recommendations for improving how they work and maximising their impact. Both evaluations were extremely positive. They reflect the opinions and perceptions of the beneficiaries and food sector stakeholders, who completed questionnaires on their assessment of the role played by the two programmes in the development of their businesses and their industry.

1.8. The independent experts tasked with the evaluation visited six countries each (PIP - Côte d'Ivoire, Dominican Republic, Kenya, Madagascar, Senegal, Uganda; EDES - Mauritania, Senegal, Cameroon, Kenya, Mauritius and the Dominican Republic) in 2013 for their field research and also met the project team in Brussels. The evaluation process concluded with a workshop presenting the findings in October 2013.

#### **PIP – Quality and Conformity Fruits and Vegetables Programme**

1.9. PIP is a cooperation programme amounting to EUR 32,5 million, supported by the European Commission and managed by COLEACP (the Europe-ACP Liaison Committee), which is an inter-professional association that represents and defends the interests of African, Caribbean and Pacific (ACP) producers/exporters and European importers of fruit, vegetables, flowers and plants. The programme aims to support producers of fruit and vegetables to comply with European SPS regulations, and in so doing, to improve the trade of agricultural products. It is financed by the European Development Fund and implemented at the request of the ACP Group of States. The second stage of PIP (PIP 2) was launched in October 2009 – following a successful first phase which started in 2001 – and will run until the end of 2015.

1.10. The evaluation found that PIP has played a role in maintaining fruit and vegetable export levels from ACP countries to the European Union by helping producers comply with food safety regulations and assimilate buyers' commercial standards and helping to professionalise agro-industry in the countries concerned.

1.11. This contribution has had a real impact on alleviating poverty, in particular by increasing the number of small-scale farmers who supply the exporters and who benefit from their oversight. However, keeping very small-scale producers in the supply chain remains a challenge due to the cost of certifications and the difficulty for exporters to practise self-assessment when production is much dispersed.

1.12. The experience gained by COLEACP during the first phase of the programme has led to great strides: the methodology was up and running, contacts with stakeholders were and still are very good, and the network of local experts was mobilised immediately. The evaluation also highlighted the programme's adaptability to changing issues, particularly the emergence of local and regional markets and the increase in social corporate responsibility standards for businesses.

1.13. Strengths identified by the evaluation include the cost advantage of the network of ACP consultants, South-South cooperation, and durability, achieved through the lasting nature of the capacity-building rolled out to large and small-scale producers. Dissemination of technical equipment and training tools via the internet also contributes to the programme's effectiveness.

1.14. The project is seen as closely associated with the private sector and, since its actions are demand-driven, as being close to beneficiaries' needs. This proximity has also helped assimilate the needs of the private sector into the project's development.

1.15. Regardless of these positive findings, the evaluation team made a number of recommendations for improving the quality and impact of the project during the second half of the implementation period.

### **PIP - Key recommendations**

- *Strengthen the capacities of other stakeholders in the horticultural sector, particularly small-scale pesticide retailers, brokers<sup>2</sup>, credit organisations and local consumer associations;*
- *Expand the areas of intervention, in particular to improve the agronomic expertise of small-scale producers, to help growers and exporters develop their business and financial management, and to give exporters the means to recognise and reject unscrupulous brokers;*
- *Make greater use of information and communication technology to provide advice and training to small-scale producers (SMS, video clips);*
- *Consider other sources of funding to promote the durability of the programme's work, and to open it up to other non-ACP and non-fruit and vegetable beneficiaries;*
- *Strengthen monitoring and evaluation systems by developing synergies with existing systems, at both state and commercial level;*
- *Continue and strengthen interactions between PIP and EDES at national level, in particular to enable a more holistic approach to preventing risks in pesticide use;*
- *Extend the programme's duration to the end of 2015 to allow it to fulfil its budgetary capacity.*

### **EDES – Development of Food Safety Systems Programme**

1.16. The EDES Programme is supported by the European Commission, and managed and implemented by a Consortium led by COLEACP, in cooperation with eight European Institutions<sup>3</sup>, which has been entrusted by the European Union to implement the programme. Launched at the request of the ACP Group of States, it has received funding worth EUR 29.5 million from the European Development Fund covering 2010-2015. The programme seeks to improve the contribution of food and feed trade to poverty reduction in ACP beneficiary countries. The purpose of the project is to ensure that risk-based food and feed safety systems for export products are established in line with regional, international and EU SPS standards. With the methodological support and expertise of the Consortium's partners, EDES develops capacity building activities, mainly through training, technical assistance, facilitation or coaching.

1.17. EDES is well received and keenly anticipated among supply chain operators, mainly due to the support it provides in adapting legislation and strengthening referral bodies (official controls, laboratories, etc.).

1.18. Despite the delay in its implementation of activities and in its financial execution, the EDES Programme has a good degree of development with an increase in actions and results thanks to an intervention strategy that proved to be effective and appropriate, even when applied late. The prolongation of the Programme for 24 months was desirable considering the effectiveness of the execution of the strategy and the pace of implementation of the Programme.

1.19. Implementing EDES is problematic in countries where dialogue between private businesses (in charge of self- assessment) and public institutions (in charge of official controls) is weak. This represents a challenge.

1.20. The evaluators expect EDES to achieve its goals thanks to its strategic approach and its ability to adapt to the realities of each country. The evaluation report highlights the effectiveness of the methodology COLEACP has developed under PIP, and from which EDES is currently benefiting, in particular the network of local consultants, the cascade approach to training, and the training tools. These synergies also help achieve economies of scale.

1.21. The EDES Programme supports local initiatives for developing sustainable and appropriate systems, taking into account local needs and the export-related requirements. Despite this, in countries where the SPS legal framework is outdated or is not harmonized with international standards, the EDES Programme could contribute to improving the legal and regulatory requirements at the request of the countries.

1.22. One of the results of the EDES Programme is the improvement of laboratory services at national and regional levels. Different users (producers, processors, etc.) need access to comprehensive and reliable analytical services. However the existing laboratory networks in ACP countries are not in a condition to meet the users' demands for several reasons: i) long delivery times for test results; ii) too few accredited laboratories; iii) low availability of reagents for tests; iv) users lack funds to pay the tests.

1.23. Finally, the evaluation indicated that the Programme is relevant to the priorities of the ACP countries and represents an opportunity for development of international dynamics and market regulations. A challenge that most of ACP countries have to face in order to maintain their market quotas and to win new ones while ensuring consumer health, is to produce in compliance with hygiene criteria and application of international SPS.

#### ***EDES - Key recommendations***

- *Continue strengthening inspection services;*
- *Step up the involvement of official controls in preparing sector-specific self-assessment guides;*
- *Strengthen synergies with PIP for improved integration of the two programmes within COLEACP;*
- *Optimise how platforms for dialogue operate between businesses and public services - a key element for ensuring the effectiveness of food safety systems;*
- *Contribute further to revision of the statutory and regulatory requirements for sanitary and phytosanitary aspects. Extend the programme's duration until the end of 2015 to compensate for the delay in implementing it.*

1.24. The European Union would like to draw attention to its report of the previous year – as found in document G/SPS/GEN/1139/Add.2 of 14 March 2014 – identifying the SPS-related technical assistance provided during 2013. This document provides more information also on other significant EU projects.
