COMMUNICATION FROM THE EUROPEAN UNION

Addendum

The following communication, received on 6 July 2017, is being circulated at the request of the Delegation of the <u>European Union</u>.

1. In response to the Secretariat's request in document G/SPS/W/101, the European Union hereby submits information on the technical assistance provided to other countries during 2015-2016, in accordance with Article 9 of the Agreement on the Application of Sanitary and Phytosanitary Measures.

2. During this period, the European Union continued to provide SPS-related technical assistance to developing countries to facilitate and enhance their ability to bring their products to the market – often with a special focus on small producers – and to take better advantage of the opportunities to trade around the world. The assistance is also geared towards improving governance and meeting international standards.

3. The technical assistance activities, listed in the attached tables, are provided by the European Commission (Annex I) and individual EU member States (Annex II). They take place at a bilateral, regional or multilateral level, through own initiatives, in conjunction with the Standards and Trade Development Facility (STDF) or under the framework of Codex, IPPC and OIE. Some of the initiatives also include non-SPS elements. In total more than 400 activities took place during 2015-2016.

4. Within the European Commission, different services are involved in the provision of SPS-related technical assistance. They are: Directorate General for International Cooperation and Development, Directorate General for Neighbourhood and Enlargement Negotiations, Directorate General for Trade and Directorate General for Health and Food Safety. In EU member States, ministries dealing with agriculture, health and related disciplines, or development agencies, lead the efforts in this field.

5. Any non-EU country requiring SPS-related technical assistance is invited to approach the EU Delegation based in their country, or the relevant directorates of the European Commission located in Brussels, Belgium or individual EU member States for further information.
