UPDATE ON THE OPERATION OF THE STANDARDS AND TRADE DEVELOPMENT FACILITY

Note by the Secretariat¹

I. OVERVIEW

- 1. The Standards and Trade Development Facility (STDF) supports developing countries in building their capacity to implement international sanitary and phytosanitary standards, guidelines and recommendations as a means to improve their human, animal and plant health status and ability to gain and maintain access to markets. In doing so, it contributes to sustainable economic growth, poverty reduction, food security and environmental protection in developing countries. The STDF helps in increasing awareness, mobilizing additional resources, strengthening collaboration and identifying and disseminating good practice to enhance the effectiveness of SPS-related technical cooperation. The STDF also provides support and funding for the development and implementation of projects that promote compliance with international SPS requirements.
- 2. The STDF is a global partnership established by the Food and Agriculture Organization of the United Nations (FAO), the World Organisation for Animal Health (OIE), the World Bank, the World Health Organization (WHO) and the World Trade Organization (WTO). Other organizations involved in SPS-related technical cooperation, donors contributing to the STDF and developing country experts participate actively in the Facility's work. The STDF is managed and housed by the WTO.²
- 3. This document provides an overview of STDF activities in support of its work programme since the previous SPS Committee meeting in March 2012 as well as information on planned work. It also provides an overview of current STDF projects and project preparation grants.

II. COORDINATION AND INFORMATION DISSEMINATION ACTIVITIES

A. STDF SEMINAR ON INTERNATIONAL TRADE AND INVASIVE ALIEN SPECIES

4. The STDF is organizing a seminar on International Trade and Invasive Alien Species (IAS) in Geneva on 12-13 July 2012 on the margins of the WTO SPS Committee meeting. The purpose of the seminar will be to raise awareness and create synergies between the SPS and environmental communities about IAS as a trade-related issue. More specifically, the seminar will seek to: (i) raise awareness about the detrimental effects of the introduction and spread of IAS for human, animal and plant health, and the importance of coherence and dialogue among SPS and environmental institutions at the national level in the development of strategies to control trade-related IAS; and (ii) review

existing technical cooperation to strengthen national capacity to manage IAS, and share experiences on the approaches adopted by countries/regions with a view to promote good practice.

- 5. The seminar has been prepared and will be delivered in close collaboration with STDF's partners, in particular the OIE and the IPPC Secretariat. A desk study on International Trade and IAS has been prepared and will be presented at the seminar. On 12 July, during lunchtime, the IPPC Secretariat will hold a side-event titled "Emerging Pathways and Challenges in the Area of Trade-Related IAS" which will include presentations on recent work related to internet trade and invasive aquatic plants.

- B. MULTI CRITERIA DECISION ANALYSIS (MCDA)
- 7. The STDF continued its work on the use of Multi Criteria Decision Analysis (MCDA) to inform decision-making on SPS capacity building and resource allocation. The STDF will participate in the application of the MCDA tool in Viet Nam in September 2012 as well as in a regional workshop for Asia scheduled for November 2012. The purpose of the latter will be to raise awareness on the MCDA approach and encourage its use as a decision-support tool in the SPS area. Government officials and other stakeholders who are interested in this regional event are encouraged to contact the STDF Secretariat for more information.

C. SPS AND TRADE FACILITATION

- 9. As part of its 2012 Work Plan, the STDF initiated the preparation of a global level event in 2013 on the links between SPS and Trade Facilitation. A first discussion on this topic took place in the STDF Working Group in March 2012. Objectives of this STDF work include raising awareness about the synergies between SPS and Trade Facilitation and identifying lessons learned and good practices to strengthen future work and technical cooperation in this area. The work will be based on examples of Trade Facilitation in the SPS area, which may include activities focused on the simplification, standardization and harmonization of SPS procedures and information systems to facilitate compliance with SPS requirements and trade, management collaboration between SPS agencies and customs to harmonize and improve SPS border management, and/or the impact of large Trade Facilitation projects on the national SPS situation.

D. STDF VIRTUAL LIBRARY

11. In August 2012, the STDF will launch the STDF Virtual Library, a central repository containing electronic documentation, including SPS needs assessments, action plans, training materials, evaluations of projects funded by the STDF and other donors, research papers and articles from various publishers and sources. Information may be provided in English, French and/or Spanish, as available. The Virtual Library will allow the STDF Secretariat to better manage a large amount of documents, inform and assist beneficiaries, international organizations, stakeholders, researchers and consultants in the development and implementation of SPS-related capacity building initiatives, and assist in further disseminating relevant experiences and good practices.

E. NEW STDF STUDIES AND PUBLICATIONS

- 13. In April 2012, the STDF released the joint STDF/Inter-American Development Bank (IDB) publication "Public-Private Partnerships to enhance SPS capacity: What can we learn from this collaborative approach?". This paper analyses the emergence, operation and performance of selected SPS-related partnerships between government agencies responsible for food safety, animal and plant health and/or trade and the private sector. It raises awareness about the potential value and role of PPPs in enhancing SPS capacity and to provide practical guidance to facilitate and promote PPPs for SPS capacity development. This publication is available on the STDF website (http://www.standardsfacility.org/Files/Publications/STDF_PublicPrivatePartnerships_EN.pdf).
- 14. As a result of collaborative efforts between the STDF and the Enhanced Integrated Framework (EIF), a practical guide on trade-related project development was produced by the Centre for International Development and Training (CIDT) at the University of Wolverhampton, UK. This handbook titled "Capacity Building in Project Identification, Formulation and Design" is now available in English on the STDF website (http://www.standardsfacility.org/en/TAIntegratedFramework.htm).

F. PARTICIPATION IN OTHER INITIATIVES

15. The STDF continued its collaboration with various other activities and initiatives in the area of SPS-related technical cooperation to monitor developments, ensure synergies, share experiences and ensure maximal coordination. The STDF participated in and contributed to a series of meetings and events, providing training, highlighting experiences and good practice and sharing information about STDF's work. This included, *inter alia*, participation in the regional WTO SPS seminar for Latin America, co-organized with the IDB (25-29 June 2012).

III. PROJECT DEVELOPMENT

- 16. Funds up to US\$50,000 are available for project preparation grants (PPGs), which can be used for any of the following purposes (or a combination thereof): (i) application of SPS-related capacity evaluation and prioritization tools; (ii) preparation of feasibility studies that precede project development to assess the potential impact and economic viability of proposals in terms of their expected costs and benefits; and/or (iii) preparation of project proposals that can be funded by the STDF or other donors.
- 17. A total of 52 PPGs have been approved and funded by the STDF since its inception. At the Working Group meeting in March 2012, two PPG applications were approved for funding:
 - STDF/PPG/370: Strengthening the Competent Authority Analytical Laboratory for fish and other potential agricultural exportable products in the Solomon Islands; and
 - STDF/PPG/377: Comprehensive Assessment and Development of a Project Proposal to Strengthen the National Plant Protection System in the Gambia


IV. PROJECT FUNDING


18. A total of 60 projects have been approved for STDF funding since its inception. In March 2012, the Working Group approved five new projects for funding:

- STDF/PG/242: Strategy to strengthen the SPS system in Comoros;
- STDF/PG/335: Strengthening the Capacity for Phytosanitary Controls of Floriculture Sector in Uganda;
- STDF/PG/344: Establishment of a Regional Virtual Food Inspection School in Central America and Dominican Republic;
- STDF/PG/354: Improving Safety and Quality of Sri Lankan Fruits and Vegetables;
- STDF/PG/358: Improving veterinary legislation in OIRSA member countries.
- 19. An overview of current STDF projects and PPGs is provided in the Annex. Since its inception, the STDF has devoted 47 per cent of project resources to LDCs and Other Low Income Countries (OLICs), as shown in Figure 1 below. Hence, the STDF continues to meet its target to devote at least 40 per cent of Facility project resources to LDCs and OLICs. Figure 2 indicates that 52 per cent of the number of STDF projects and PPGs has gone to Sub-Saharan Africa, 17 per cent to Asia, and 14 per cent to Latin America and the Caribbean. In addition, 11 per cent of STDF projects and PPGs can be classified as global.

20. Applications for STDF funding can be made at any point in the year but should be received at least 60 working days in advance of each Working Group meeting in order to be considered at that meeting. The next deadline for the submission of applications is 20 July 2012.
