## UPDATE ON THE OPERATION OF THE STANDARDS AND TRADE DEVELOPMENT FACILITY

Note by the Secretariat<sup>1</sup>

## I. OVERVIEW

1. The Standards and Trade Development Facility (STDF) supports developing countries in building their capacity to implement international sanitary and phytosanitary standards, guidelines and recommendations as a means to improve their human, animal and plant health status and ability to gain and maintain access to markets. In doing so, it contributes to sustainable economic growth, poverty reduction, food security and environmental protection in developing countries. The STDF helps in increasing awareness, mobilizing additional resources, strengthening collaboration and identifying and disseminating good practice to enhance the effectiveness of SPS-related technical cooperation. The STDF also provides support and funding for the development and implementation of projects that promote compliance with international SPS requirements.

2. The STDF is a global partnership established by the Food and Agriculture Organization of the United Nations (FAO), the World Organisation for Animal Health (OIE), the World Bank, the World Health Organization (WHO) and the World Trade Organization (WTO). Other organizations involved in SPS-related technical cooperation, donors contributing to the STDF and developing country experts participate actively in the Facility's work. The STDF is managed and housed by the WTO.<sup>2</sup>

3. This document provides an overview of STDF activities in support of its work programme since the previous SPS Committee meeting in July 2012 as well as information on planned work. It also provides an overview of current STDF projects and project preparation grants.

4. ## II. COORDINATION AND INFORMATION DISSEMINATION ACTIVITIES

A. STDF SEMINAR ON INTERNATIONAL TRADE AND INVASIVE ALIEN SPECIES

5. The STDF, in collaboration with the Secretariat of the International Plant Protection Convention (IPPC) and the World Organisation for Animal Health (OIE), organized a seminar on

International Trade and Invasive Alien Species (IAS) in Geneva on 12-13 July 2012. The seminar, attended by 110 participants, sought to raise awareness about the mutually supportive objectives of the WTO SPS Agreement and the Convention on Biological Diversity (CBD), and the contribution of effective SPS control systems to help protect against the entry of harmful species, including pests, diseases and other IAS.

6. Participants agreed on the following conclusions and actions to improve the management of trade-related IAS:

- Measures applied to prevent the entry, spread and establishment of IAS via trade, that aim to protect human, animal and plant life or health or territory, fall within the scope of the SPS Agreement and should abide by its provisions;
- Risk-based approaches under the SPS Agreement are a key tool in preventing the movement of organisms that have potential to become invasive;
- Countries are encouraged to use the relevant IPPC and OIE guidelines in dealing with IAS;
- International organizations should further collaborate to enhance the implementation of the SPS Agreement and the CBD;
- Increased SPS capacity building efforts will ensure that international standards are adequately implemented to prevent trade from spreading harmful alien species; and
- Regional approaches are effective in the prevention and control of IAS, which do not respect political borders, and regional networks are useful means to share relevant experiences and knowledge.

7. On 12 July the IPPC Secretariat held a successful side-event entitled "Emerging Pathways and Challenges in the Area of Trade-Related IAS" which included a presentation on recent work related to internet trade and invasive aquatic plants.

## B. MULTI CRITERIA DECISION ANALYSIS (MCDA)

9. The STDF continued its work on the application of Multi Criteria Decision Analysis (MCDA) to inform decision-making on SPS capacity building and resource allocation. The STDF facilitated application of the MCDA tool in Viet Nam in September 2012 and will organize a regional workshop for selected experts in food safety, animal and/or plant health and trade from Asian and Pacific countries in Bangkok, Thailand on 12-13 November 2012. The objectives of the regional workshop will be to:

- increase knowledge about the MCDA Tool and its use to prioritize SPS capacity building needs;
- provide practical skills to enable participants to apply the MCDA Tool in their countries and use the associated computer software; and
- obtain feedback to further improve the MCDA Tool.

10. The selection of SPS experts to participate in this workshop has been completed. More information on the MCDA tool, including previous STDF events and publications, can be found on the STDF website (<u>http://www.standardsfacility.org/en/TAEcoAnalysis.htm</u>).

## C. SPS AND TRADE FACILITATION

11. As part of its 2012 Work Plan, the STDF initiated preparatory work on the linkages between SPS and Trade Facilitation, in collaboration with the World Bank, the Inter-American Development Bank (IDB) and other interested regional development banks and organizations. The purpose of this work, to be carried out in 2013, will be to enhance understanding among SPS practitioners and staff of customs authorities in developing countries about the role of SPS agencies in trade facilitation, and to identify key needs, opportunities and good practices to enhance the effective engagement of SPS agencies in collaborative border management.

12. This work will be further discussed in the STDF Working Group on 11-12 October 2012 and may include: (i) regional research in Africa, Asia and the Pacific, and Latin America to identify, analyse and document examples of how SPS agencies are supporting and/or hampering trade facilitation, and the publication of three regional reports; (ii) publication of a synthesis study, targeted at SPS and customs agencies, that analyses available experiences, identifies good practices and lessons learned, and makes recommendations to promote and enhance the role of SPS agencies in collaborative border management; and (iii) organization of a global-level event on SPS and Trade Facilitation in the second half of 2013 (venue and date to be confirmed) to raise awareness on the role of SPS agencies in trade facilitation, and present and discuss the findings and recommendations of the regional research work.

13. Key questions to be addressed during the research may include:

- What is the current role of SPS agencies in collaborative border management?
- How are SPS agencies working with customs and other border agencies in the area of trade facilitation?
- How are SPS agencies using risk management principles and modern tools (e.g. X-ray equipment, IT) to improve inspection-detection?
- What is the actual and potential role of the private sector in enhancing compliance with SPS regulatory control objectives at the border?
- What is the role of regional institutions, donors and development partners in supporting the effective engagement of SPS agencies in collaborative border management and trade facilitation initiatives?
- Which factors influence the engagement of SPS authorities in collaborative border management?

14. Members are encouraged to share information with the STDF Secretariat on their experiences in the area of SPS and Trade Facilitation, as outlined above, by email (STDFSecretariat@wto.org).

## D. STDF VIRTUAL LIBRARY

15. In November 2012, the STDF will launch the STDF Virtual Library, a central repository containing SPS-related electronic documentation, including SPS needs assessments, action plans, training materials, evaluations of projects funded by the STDF and other donors, research papers and

articles from various publishers and sources. Information is provided in English, French and/or Spanish, as available. The Virtual Library will allow the STDF Secretariat to better manage a large amount of documentation, inform and assist beneficiaries, international organizations, stakeholders, researchers and consultants in the development and implementation of SPS-related capacity building initiatives, and further facilitate the dissemination of relevant experiences and good practices.

16. The Virtual Library will be accessible on the STDF website. Members are encouraged to share documents related to SPS technical cooperation and capacity building for inclusion in the Virtual Library, as outlined above, with the Secretariat by email (STDFSecretariat@wto.org).

E. JOINT AUC /STDF MEETING ON REGIONAL SPS COORDINATION AND CAPACITY BUILDING

17. The STDF facilitated the organization of a joint meeting with the African Union Commission (AUC) on regional SPS coordination and capacity building in Africa in Addis Ababa, Ethiopia on 28 September 2012. The meeting was attended by approximately 25 officials of the AUC and its technical agencies, SPS representatives of Regional Economic Communities (RECs) and relevant international organizations. The purpose was to discuss the role and function of the AUC, its technical offices and the RECs in adding value to SPS coordination and capacity building initiatives at the continental, regional and national level<sup>3</sup>. The Secretariat and STDF partners will report on the outcomes of this event to the STDF Working Group on 11-12 October.

F. STUDY ON SPILL OVER EFFECTS OF EXPORT-ORIENTED SPS TECHNICAL ASSISTANCE ON DOMESTIC FOOD SAFETY SITUATION

18. The STDF, in close collaboration with FAO and WHO, will commission a study on the spill over effects of export-oriented SPS technical assistance on the domestic food safety situation. The aim will be to draw key lessons to improve the design and delivery of future trade related technical assistance programmes. A background note summarizing the rationale, objectives and a proposed work plan will be discussed by the Working Group on 11-12 October. Implementation of this work is expected to start in November 2012 and will include an open call for relevant projects and programmes to be analysed during the course of this work.

G. PARTICIPATION IN OTHER INITIATIVES

19. The STDF continued its collaboration with various other activities and initiatives in the area of SPS-related technical cooperation to monitor developments, ensure synergies, share experiences and ensure maximal coordination. The STDF participated in and contributed to a series of meetings and events, providing training, highlighting experiences and good practice and sharing information about STDF's work. This included, *inter alia*, participation in a Workshop on SPS Measures for countries of the Central Asia Regional Economic Cooperation (CAREC) program, organized by the ADB (25-26 July), the Second Meeting of the SADC SPS Coordinating Committee (24-27 July) and the Fourth Technical Meeting of the COMESA SPS Sub-Committee (20-22 August).

# III. PROJECT DEVELOPMENT

20. Funds up to US\$50,000 are available for project preparation grants (PPGs), which can be used for any of the following purposes (or a combination thereof): (i) application of SPS-related capacity evaluation and prioritization tools; (ii) preparation of feasibility studies that precede project development to assess the potential impact and economic viability of proposals in terms of their

expected costs and benefits; and/or (iii) preparation of project proposals that can be funded by the STDF or other donors. A total of 52 PPGs have been approved and funded by the STDF since its inception.


21. It is expected that the STDF Working Group will approve additional PPGs for funding at its next meeting on 11-12 October.

## **IV. PROJECT FUNDING**

22. Project grant financing up to a maximum of US\$1,000,000 is available from the STDF. Favourable consideration is given to projects that focus on one or more of the following: (i) the identification, development and dissemination of good practice in SPS-related technical cooperation, including the development and application of innovative and replicable approaches; (ii) STDF work on cross-cutting topics of common interest; (iii) the use of regional approaches to address SPS constraints; and/or (iv) collaborative and interdisciplinary approaches focused on the interface / linkages between human, animal and plant health and trade, and benefiting from the involvement of two or more STDF partners or other relevant organizations. A total of 60 projects have been approved for STDF funding since its inception.

23. It is expected that the STDF Working Group will approve additional projects for funding at its next meeting on 11-12 October.

24. An overview of current STDF projects and PPGs is provided in the Annex. Since its inception, the STDF has devoted 47 per cent of project resources to LDCs and Other Low Income Countries (OLICs), as shown in Figure 1 below. Hence, the STDF continues to meet its target to devote at least 40 per cent of Facility project resources to LDCs and OLICs. Figure 2 indicates that 52 per cent of the number of STDF projects and PPGs has gone to Sub-Saharan Africa, 17 per cent to Asia, and 14 per cent to Latin America and the Caribbean. In addition, 11 per cent of STDF projects and PPGs can be classified as global.



25. Applications for STDF funding can be made at any point in the year but should be received at least 60 working days in advance of each Working Group meeting in order to be considered at that meeting. The next deadline for the submission of applications is <u>28 December 2012</u>.
