## CHANGES TO LICENCES AND CERTIFICATES ISSUED BY THE AGRI-FOOD AND VETERINARY AUTHORITY OF SINGAPORE

## COMMUNICATION BY SINGAPORE

The following communication, dated 6 November 2014, is being circulated at the request of the delegation of <u>Singapore</u>.

- 1. Singapore is providing the following information for the attention of the competent authorities for animal health, plant health and food safety of other Members.
- 2. The Agri-Food and Veterinary Authority of Singapore (AVA) is upgrading its licensing e-services to deliver a more user-friendly and efficient licensing experience for businesses.
- 3. Arising from the new system, the following licences and certificates would be issued in new formats:
  - a. Licence to Import Animals/Birds/Eggs/Biologics;
  - b. Licence to Transship Animals/Birds/Eggs/Biologics;
  - c. Licence to Export Animals/Birds/Eggs;
  - d. Veterinary Certificate for Animals and Animal Products;
  - e. Certificate of Freedom from Disease within Singapore;
  - f. Free Sale Certificate (Animal Feed);
  - g. Free Sale Certificate (Veterinary Vaccines);
  - h. Free Sale Certificate (Food);
  - i. Food Export Certificate.

Licences and certificates (d) - (i) will be issued with an optical watermark similar to that used in existing certificates. - 4. The new licences and certificates will be issued <u>from 3 November 2014 onwards</u>. However, we wish to advise you that it is likely that from this date onwards, both formats of certificates and licences, i.e. the existing certificates and licenses and the new ones, may be presented over a period of time. This is due to the validity period of certificates and licenses issued prior to 3 November 2014. We hope that your authorities are familiar with AVA's existing and new licences and certificates and that the introduction of the new format of certificates and licenses will not cause any disruption to trade.
- 5. We would also like to inform that competent authorities can apply for a user ID account to login into "AVA e-Licensing" to verify authenticity of the listed licences and certificates issued by the AVA.
