UPDATE ON THE OPERATION OF THE STANDARDS AND TRADE DEVELOPMENT FACILITY

NOTE BY THE SECRETARIAT1

1 OVERVIEW

- 1.1. The Standards and Trade Development Facility (STDF) is a global partnership that supports developing countries to implement international food safety, animal and plant health standards, guidelines and recommendations to gain and maintain access to markets. In doing so, the partnership contributes to broader development goals of sustainable economic growth, poverty reduction and food security. Reduction of pest and disease burdens, and improved food safety, have a key role in raising agricultural production, reducing the prevalence of food-borne diseases, increasing food availability, and the protection of the environment.
- 1.2. The STDF was established by the Food and Agriculture Organization of the United Nations (FAO), the World Organisation for Animal Health (OIE), the World Bank, the World Health Organization (WHO) and the World Trade Organization (WTO) (the founding partners). Other organizations involved in SPS-related technical cooperation, donors contributing funds to the STDF and selected developing country experts participate actively in the Facility's work. The Secretariats of the Codex Alimentarius Commission and the International Plant Protection Convention (IPPC) also participate in the partnership. The STDF is managed and housed by the WTO.
- 1.3. Specifically, the STDF acts as a coordinating and financing mechanism.² The partnership at the heart of the STDF is its key added-value. By bringing together the SPS expertise and skills of its founding partners and other organizations, the STDF provides a unique forum to exchange information, encourage collaboration and synergies in SPS capacity building, enabling the stakeholders involved to achieve more effective and sustainable results together, than would be possible alone. As a financing mechanism, STDF provides grants for projects and to support project formulation based on appropriate assessment of the SPS-related capacity building needs. Applications are particularly encouraged from Least Developed Countries (LDCs).
- 1.4. This document provides an update on STDF's work since the last SPS Committee meeting in March 2015. Annex 1 provides a brief overview of all on-going STDF projects and project preparation grants (PPGs). Delegates who would like to receive more information are invited to visit the STDF website and subscribe to the STDF electronic mailing list.3 The STDF Working Group will have its next meeting on 12-13 October 2015.

2 IMPLEMENTING SPS MEASURES TO FACILITATE SAFE TRADE

2.1. The STDF has produced a new short film, entitled "Safe Trade Solutions", which highlights selected examples of good practice in the implementation of SPS measures to facilitate safe trade at the border from three countries in South America (Chile, Peru and Colombia). This new film aims to provide a training and awareness-raising tool for SPS practitioners, as well as other border agencies. It will be launched during the high-level plenary session, entitled "Effective

Implementation of SPS Measures to Facilitate Safe Trade", organized by WTO on 30 June as part of the Fifth Global Review of Aid for Trade, which takes place under the theme "Reducing Trade Costs for Inclusive, Sustainable Growth".

- 2.2. The aforementioned plenary session will focus on how trade facilitation can be married with robust, science and risk-based SPS controls, and the role that Aid for Trade can play in ensuring that these twin goals are met. It will enable STDF partners and other stakeholders to discuss opportunities to leverage funds and strengthen SPS capacity linked to the new WTO Trade Facilitation Agreement (TFA), as well as concerns that the TFA may erode the ability to protect human, animal and plant health from risks associated with the importation of food and plant products. More information on the Global Review is available on the WTO website.⁴
- 2.3. The STDF has carried out research in selected countries in Southeast Asia and Africa on how SPS controls are implemented for select agri-food products, based on the relevant provisions of the SPS Agreement (notably Article 8 and Annex C on Control, Inspection and Approval Procedures). This work aimed to identify key needs, opportunities and good practices to improve the implementation of SPS measures in a way that facilitates safe trade, and also strengthens health protection. The consultant's report for Southeast Asia (focused on Cambodia, Lao People's Democratic Republic, the Philippines and Thailand) is available on the STDF website. The report of the research in Malawi, South Africa and Zambia is being finalized.

3 JOINT EIF/STDF ANALYSIS ON SPS ISSUES IN DTIS STUDIES

3.1. The STDF and the Enhanced Integrated Framework (EIF) Secretariat are preparing a joint study that analyses the coverage of SPS issues in EIF Diagnostic Trade Integration Studies (DTIS) and identifies good practice for future studies and their implementation. Following a preliminary review of all DTIS reports, Cambodia, Tanzania and Senegal were selected for an in-depth field study, while an additional twenty DTIS reports were selected for further desk review. Preliminary results will be shared and discussed in the STDF Working Group. The study will be finalized in 2015 and made available on the STDF website.

4 CALL FOR DOCUMENTS FOR STDF VIRTUAL LIBRARY

4.1. The STDF Virtual Library is an online information repository providing quick and easy online access to a variety of information resources focused on SPS technical cooperation and capacity building. Members and observer organizations are requested to submit relevant documents to the Secretariat (STDFSecretariat@wto.org) for inclusion in the Library. These may include: project documents and final reports, training materials, project evaluations/reviews, SPS capacity needs assessments, cost-benefit analyses, case studies, relevant research papers and other articles on SPS capacity building.

5 PROJECT DEVELOPMENT

- 5.1. The STDF provides advice and support to applicants on issues related to SPS project development and finances project preparation grants (PPGs). This assists applicants in the articulation of their SPS needs and the development of technically sound and sustainable project proposals. Seed funding up to US\$50,000 is available for PPGs, which can be used for any of the following purposes (or a combination thereof): (i) application of SPS-related capacity evaluation and prioritization tools; (ii) preparation of feasibility studies that precede project development to assess the potential impact and economic viability of proposals (expected costs and benefits); and/or (iii) preparation of project proposals that can be funded by other donors or STDF.
- 5.2. A total of 66 PPGs have been approved and funded by the STDF since its inception. The STDF Working Group may approve additional PPGs for funding at its next meeting on 12-13 October 2015.

6 PROJECT IMPLEMENTATION

- 6.1. Project grant financing up to a maximum of US\$1,000,000 is available from the STDF. Favourable consideration is given to projects that focus on one or more of the following: (i) identification, development and dissemination of good practice in SPS-related technical cooperation, including the development and application of innovative and replicable approaches; (ii) regional approaches to address SPS constraints; and/or (iii) implementation of collaborative approaches across food safety, animal and plant health and trade, and benefiting from the involvement of two or more STDF partners or other relevant organizations.
- 6.2. Beneficiaries must contribute to the project from their own resources, either in the form of financial or in-kind contributions such as staff time, use of premises, vehicles or other existing assets.
- 6.3. A total of 72 projects have been approved for STDF funding since its inception. The STDF Working Group may approve additional projects for funding at its next meeting on 12-13 October 2015.
- 6.4. Annex 1 provides an overview of on-going STDF projects and PPGs. Since its inception, the STDF has devoted 56% of its project and PPG resources to LDCs and other low income countries (OLICs), as shown in Figure 1. Hence, the STDF is consistently meeting its target to devote at least 40% of its project and PPG resources to LDCs and OLICs. In particular the allocation of PPG resources to LDCs and OLICs remains high (i.e. 74% of the overall budget for PPGs).

Figure 1: STDF projects and PPGs (US\$)




Figure 2: STDF Projects and PPGs (number)

- 6.5. Figure 2 above indicates that 51% of the number of STDF projects and PPGs has gone to Sub-Saharan Africa, 20% to Asia, and 17% to Latin America and the Caribbean. In addition, 10% of STDF projects and PPGs can be classified as global.
- 6.6. Applications for STDF funding can be made at any point in the year but should be received at least 60 working days in advance of each Working Group meeting in order to be considered at that meeting. The next deadline for the submission of applications is **17 July 2015**. Further information on eligibility criteria, application forms, etc. is available on the STDF website.

7 PROJECTS APPROVED IN MARCH 2015

- 7.1. The STDF Working Group at its meeting on 24 March 2015 approved the following PPG and Projects:
 - a. STDF/PPG/447- Development of a project proposal to address SPS capacity needs focusing on the national food safety system in <u>Tajikistan</u>: The PPG aims to assist Tajikistan in implementing the National Food Safety Strategy and Food Law and identify priority areas for food safety capacity building.
 - b. STDF/PG/502- Regional strengthening for the implementation of phytosanitary measures and market access in <u>COSAVE</u>: The project aims to strengthen the capacity to implement phytosanitary measures as a means to maintain and improve the phytosanitary status of countries in the COSAVE region (comprising Argentina, Bolivia, Brazil, Chile, Paraguay, Peru and Uruguay). Specifically, the project aims to develop a regional phytosanitary information database, build regional technical capacity to conduct pest risk analysis and strengthen NPPO's phytosanitary inspection and certification capacity.
 - c. **STDF/PG/515- Honey Chain traceability in** <u>Guatemala</u>: This project seeks to maintain market access and increase the volume of honey exports from Guatemala through the implementation of an electronic traceability system.
