**SUMMARY OF THE REPLIES TO THE QUESTIONNAIRE ON
SPS-RELATED WEB SITES**

Note by the Secretariat

1. At the 7-8 July 1999 meeting of the SPS Committee, the Secretariat informed Members that it would circulate a questionnaire to collect information on resources available on Members' web sites. The questionnaire (G/SPS/W/102) was circulated on 29 July 1999 and Members were requested to submit their replies by 24 September 1999, at the latest.
2. The Secretariat received 13 replies to the questionnaire, including replies from four EC member States. Members will find attached the compilation of the addresses of Members' SPS-related web sites. Also included are the web sites provided by the European Communities at the July 1999 Committee meeting. The Secretariat intends to place the list in the WTO homepage and establish appropriate links.
3. The following additional Members indicated that they were in the process of establishing their SPS-related web sites, or had plans to do so in the near future: Cyprus, Czech Republic, Latvia and the Philippines. Latvia would welcome technical assistance to facilitate this process. Egypt provided no web site addresses, but indicated that the Ministry of Agriculture and Land Reclamation and its affiliated bodies had an animal health information network as well as an information net comprising SPS rules and procedures in general.
