The **Codex Committee on Food Hygiene** will consider in particular: revision of the *General Principles of Food Hygiene* (CAC/RCP 1-1969) and its HACCP Annex; revision of the *Code of Hygienic Practice for Fresh Fruits and Vegetables* (CAC/RCP 53-2003); development of Guidance on histamine control and sampling plans for histamine.

2.2. Note: New round of FAO/WHO Regional Coordinating Committees (RCCs) started in September 2016 from CCNASWP. CAC38 (2015) welcomed a process of "revitalisation" of RCCs to make them more strategic forward thinking on food safety and quality issues related to the region. The "revitalisation" process include among others the alignment of the agenda of the six RCCs and the development of a platform to collect and share information on food control.
