SPS TECHNICAL ASSISTANCE AND TRAINING ACTIVITIES 1 JANUARY 2020 TO 30 JUNE 2020

NOTE BY THE SECRETARIAT1

Addendum

- 1. This document provides an update on the SPS technical assistance (TA) and the training activities that have been delivered via videoconference by the WTO Secretariat from 1 January 2020 to 30 June 2020.² Due to the COVID-19 pandemic, the Secretariat has had to review the planned technical assistance activities on the Agreement on the Application of Sanitary and Phytosanitary Measures (SPS Agreement) that were to be delivered in 2020.³ In this regard, the Secretariat has been organizing tailored SPS-related training delivered via videoconference, as the previously scheduled in-person activities were not possible during the identified period.
- 2. In the first half of 2020, five SPS training activities were undertaken via videoconference: two national training activities on the use of the SPS eAgenda,⁴ two on the use of the ePing alert system and one in the context of the follow-up of the 2019 Advanced SPS Course.⁵
- 3. The annexed table identifies, for the period 1 January to 30 June 2020, the type of technical assistance activity, its dates, participating countries, language used, and whether representatives from the FAO/WHO Codex Alimentarius Commission (Codex), the World Organisation for Animal Health (OIE), and the International Plant Protection Convention (IPPC) Secretariat participated in the activity.

This system was being used for the first time ahead of the June 2020 SPS Committee meeting. It had only previously been used on a trial basis by some Members in the testing phase.

⁵ The Advanced SPS Course includes a follow-up activity which is held back-to-back with the June/July SPS Committee meeting of the following year. The face-to-face follow-up activity was originally planned to be held from 17 to 26 June 2020 in Geneva, Switzerland, but had to be postponed. In the interim, the Secretariat has organized short virtual sessions with participants.
