SPS TECHNICAL ASSISTANCE AND TRAINING ACTIVITIES 1 SEPTEMBER 1994 TO 31 DECEMBER 2020

NOTE BY THE SECRETARIAT1

Revision

- 1. This document provides an update of all the SPS technical assistance (TA) and training activities undertaken by the Secretariat from 1 September 1994 to 31 December 2020. Detailed information is provided in the annexed table on the TA activities undertaken by the Secretariat for the last three years (2018-2020).²
- 2. The main objective of SPS technical assistance and training activities undertaken by the WTO Secretariat is to increase participants' awareness about Members' rights and obligations under the Agreement on the Application of Sanitary and Phytosanitary Measures (SPS Agreement) and its implications for national policymaking. The SPS technical assistance activities also provide an opportunity to inform participants on the discussions held and latest documents considered by the SPS Committee. In addition, participants are informed about upcoming SPS workshops and technical assistance initiatives available to their countries on SPS matters.
- 3. The programme is adapted to take into account the specific needs identified by the countries, the participants' knowledge of the SPS Agreement, the level of development of the countries, and any specific concerns relating to the implementation of the SPS Agreement, in order to adequately respond to individual requests. SPS technical assistance and training activities typically include presentations on the basic provisions of the SPS Agreement, the transparency provisions, specific trade concerns raised at the SPS Committee, the WTO dispute settlement and SPS-related cases, and specific issues such as risk analysis, regionalization or equivalence.
- 4. Due to the ongoing COVID-19 pandemic, the Secretariat reviewed the planned technical assistance activities on the SPS Agreement scheduled to be delivered in 2020.³ In this regard, the Secretariat organized tailored SPS-related training delivered via videoconference, as in-person activities were not possible for most of the identified period.
- 5. Altogether, 425 SPS training activities have been undertaken by the WTO Secretariat from 1 September 1994 to 31 December 2020. In 2020, 12 SPS training activities were undertaken: eight national seminars, one regional workshop and three other activities (including two dedicated trainings on the ePing alert system and an APEC Regional Workshop).⁴

- 6. The annexed table identifies, for the period 2018-2020, the type of technical assistance activity, the region and venue where it took place, its dates, participating countries, language used, and whether representatives from the FAO/WHO Codex Alimentarius Commission (Codex), the World Organisation for Animal Health (OIE), and the International Plant Protection Convention (IPPC) Secretariat participated in the activity.
- 7. A <u>regional workshop</u> refers to an activity organized by the WTO in which a region or sub-region was invited to participate. A <u>national seminar</u> refers to a WTO-organized activity undertaken at the national level only. The "<u>other</u>" category refers to all other SPS TA and training activities that do not fall under either of the first two categories. This includes other types of SPS-specific activities organized by the WTO Secretariat as well as activities organized by Members or other bodies in which the WTO Secretariat participated. Training sessions on the SPS Agreement also take place within other general WTO training courses, such as Trade Policy Courses, Regional Trade Policy Courses, Geneva Weeks, Introduction Courses and Agriculture Courses for least-developed countries; which are not included in the list of SPS TA activities in this document.
- 8. The information provided in the Annex below is organized on an annual basis and in alphabetical order, based on the region where the activity was undertaken, with the more recent activities listed first.
- 9. SPS TA activities are organized in close collaboration with Members, the three-international standard-setting bodies referenced in the SPS Agreement (Codex, IPPC and OIE), as well as with regional organizations, when appropriate. Since 1994, the Codex has participated in 119 activities, while the IPPC secretariat participated in 103 activities and the OIE in 117 activities.
- 10. To meet the demands for more advanced SPS TA and training activities, a three-week Advanced Course on the SPS Agreement⁵ has normally been offered each year since 2005.⁶ However, this course, originally scheduled to be held from 26 October to 13 November 2020 in Geneva, Switzerland, in French, had to be cancelled due to the ongoing COVID-19 pandemic. The follow-up activity to the 2019 Advanced SPS Course, which was scheduled to be held face-to-face in June 2020, was organised through videoconference.
- 11. In addition to the above-mentioned SPS TA and training activities, the WTO offers an E-Learning course on the SPS Agreement. The course is offered each year in all three official languages of the WTO: English, French and Spanish.⁷
- 12. Since 2010, Members have been informed at the beginning of each year of all SPS-related planned technical assistance activities, and interested officials are invited to submit applications for specific events. In 2020, this was done via documents G/SPS/GEN/997/Rev.10 of 3 March 2020, G/SPS/GEN/997/Rev.10/Add.1 of 10 June 2020 and G/SPS/GEN/997/Rev.10/Add.2 of 20 October 2020. Approximately 90 applications were received for the SPS Regional SPS Workshop for Latin America, with a focus on transparency and the role of National Notification Authorities, co-organized with the Inter-American Institute for Cooperation on Agriculture. Candidates were required to have successfully completed the WTO E-Learning course on the SPS Agreement at the time of their application. All applicants were requested to provide information that indicated how their professional responsibilities were related to the SPS Agreement, and the endorsement of Members' permanent representations to the WTO was sought before the final selection of participants. The Secretariat endeavoured to ensure that the selected participants represented a balance of officials with responsibilities in their national administrations' food safety, animal health or plant protection areas, as well as SPS enquiry points and national notification authorities, and

other officials responsible for the coordination of WTO trade issues and SPS matters within their governments.

- 13. The Secretariat considers that this more "demand-driven" approach, based on applications from interested officials, together with the pre-requisite of completion of the SPS E-Learning course, has resulted in a more homogeneous and higher level of background knowledge by participants, and permitted the delivery of more advanced and effective training activities since 2010. The Secretariat will again organize its 2021 training activities in this manner, as indicated in document G/SPS/GEN/997/Rev.11. In addition, the activities planned for 2021 are currently scheduled to be delivered through videoconference or virtual platforms.
- 14. Chart 1 below lists the breakdown of the type of activities undertaken in 2020 and Chart 2 shows the number of activities per year.





Chart 1 - SPS TA and Training Activities in 2020





15. Chart 3 presents a breakdown of the type of activities undertaken since 1994: 201 national seminars, 99 regional or sub-regional workshops, 110 other activities and fifteen Advanced Courses on the SPS Agreement.

16. Chart 4 shows the number and type of TA activities per region, while Chart 5 presents the total number of participants who have attended SPS TA and training activities per region and per type of activity. Overall, a total of 16,493 people have received training from the WTO Secretariat on the SPS Agreement since 1994.




Chart 4 - SPS TA and Training Activities per Region from 1994 to 2020




Chart 5 - Participants per Region from 1994 to 2020

17. As shown in Chart 6, 30% of the beneficiaries of all SPS TA and training activities undertaken by the Secretariat have been from least-developed countries (LDCs), 68% from developing countries, and 2% from developed countries.




Chart 6 - Breakdown of country participation from 1994 to 2020

18. Chart 7 presents a breakdown by region of participants who have attended the Advanced SPS Course. Over the period 2005 to 2020, 360 officials have participated in the Advanced SPS Course from the following regions: 37% from Africa; 34% from Latin America and the Caribbean; 16% from Asia and Pacific; 10% from Central and Eastern Europe, Central Asia and the Caucasus; and 3% from Arab and Middle East countries.⁸

19. Chart 8 presents the language breakdown of all SPS TA and training activities that have been undertaken. Overall, 62% of activities have been conducted in English, 20% in Spanish, and 12% in French. The remaining 6% have been undertaken in other languages, including Arabic, Portuguese, Turkish and Russian. 9




Chart 8 - Language breakdown of SPS TA and Training activities from 1994 to 2020
