Fifth Progress Report (January - June 2005)

A. INTRODUCTION

1. This is the fifth progress report on the FAO/WHO Project and Fund for Enhanced Participation in Codex. It covers activities for the first half of 2005 and follows on from the information contained in the Annual Report for 2004 (ALINORM 05/28/9F).

B. TECHNICAL SECTION

2005 Applications and participation

2. Applications for support in 2005 from the Codex Trust Fund closed on 31 December 20041. Ninety-one countries applied for support to send nearly 300 participants to Codex meetings in 2005. These applications were considered by the FAO/WHO Consultative Group on the Trust Fund (CGTF) for the FAO/WHO Project and Fund for Enhanced Participation in Codex. As the CCAFRICA session held in January 2005 had been postponed from December 2004, for the purposes of processing 2005 applications CCAFRICA was counted as a 2004 session, thus not penalizing the right of eligible countries that had participated.

3. For the period January to June 2005, 150 delegates2 from 78 countries were supported to attend 12 Codex meetings. All of these delegates were funded entirely by the Codex Trust Fund and most were from Least Developed Countries (LDCs). The breakdown of participants was: 61% from LDCs and other lower income countries; 28% from lower middle income countries; and 11% from upper middle income countries. Annex A provides details of the countries supported. Total costs to the Codex Trust Fund for this support was US\$ 948,120 (including administrative and management costs). The total average cost, including all administrative functions related to the trust fund, was therefore US\$ 6,320 per participant.

4. For the period July to December 2005, 97 delegates from 66 countries are expected to be supported to attend five Codex meetings (including the Codex Alimentarius Commission (CAC) Twenty-eighth Session in Rome in July 2005). The expected breakdown of participants from July to December 2005 is: 62% from LDCs and other lower income countries; 29% from lower middle income countries; and 9% from upper middle income countries. Annex B provides details of this proposed support. This will bring the total figures for 2005 to 61% from LDCs and other lower income countries; 28% from lower middle income countries; and 11% from upper middle income countries.

5. The majority of 2005 applications sought financial support to attend Codex meetings; however, two countries specifically sought to strengthen their capacity through support by way of

training. In January 2004, Switzerland contributed US\$20,000 and Canada contributed US\$25,057 to develop the Codex Training Package and conduct training courses/workshops using this Package. In March 2004, the Codex Training Package was field tested in Dar Es Salaam, Tanzania. It was also used, in draft form, in relevant FAO training activities in Burkina-Faso and Syria. The Codex Training Manual is now finalized and will shortly be available in six languages (Arabic, Chinese, English, French, Russian and Spanish). A preliminary edition in English and possibly other languages will be available at the CAC in July 2005. The CGTF had decided that the remaining amount (from the above funds) will be used to conduct regional training courses on Codex during the second half of 2005. Details of this training are expected to be announced in July 2005.

2006 Applications

6. Application forms for support by way of Codex meeting attendance, training and other activities in 2006 are expected to be available on these websites from July 2005 together with full details of eligibility and application procedure:

WHO website (www.who.int/foodsafety/codex/trustfund), FAO website (www.fao.org/es/ESN/food/capacity_en.stm), and Codex website (www.codexalimentarius.net/web/index_en.jsp).

A note advising of these application forms will be sent to countries through the Codex Email lists (Codex-L and Codex-Direct-L) and other channels. Applications for support from the Trust Fund for the year 2006 are required to be received by the WHO Secretariat for the Trust Fund no later than 31 October 2005. A prerequisite for the positive consideration of countries' 2006 applications will be the provision of any outstanding reports from the participants supported from the Trust Fund up to 31 July 2005.

C. FINANCIAL SECTION

7. In 2003-2004, a total of US\$ 1,543,090 was contributed to the fund. During the period January to June 2005, a total of US\$ 579,926 was received in contributions from Canada, the European Commission, and Germany. Table 1 provides the breakdown.

8. Three additional contributions to the Trust Fund are expected in 2005. These are:

<u>European Commission</u>: The final payment of EUR 14,750 for the EC's first annual contribution (approximately US\$ 19,000).

<u>Sweden</u>: A 3-year Agreement for the 2005-2007 period is expected to be finalized, which will entail a Swedish Government contribution of SEK 3.0 million per year (approximately US\$ 425,000 per year), thereby resulting in the contribution of US\$ 425,000 for 2005.

<u>Netherlands</u>: According to the 4-year Agreement (2003-2006), the Netherlands will contribute US\$ 50,000 in 2005.

This will result in a total amount of approximately US\$ 1,074,000 flowing into the fund in 2005. Including the US \$745,711 contributions from 2004 defined for use in 2005 and which have all been allocated, there will be a total of approximately US \$1,820,000 available for use in 2005. Further contributions and pledges received in 2005 will be transferred to the 2006 budget.

D. OTHER ISSUES

Eligibility

9. As of 17 May 2005, 134 of the 171 Codex member countries were eligible to apply for support from the Trust Fund. Eligibility is reviewed annually by the CGTF and is based on UN and World Bank classifications of Least Developed, Low Income, Lower Middle Income and Upper Middle Income Countries.

10. It is worth noting that of the 21 countries which are not currently members of Codex, 18 would probably be eligible to apply for support from the Codex Trust Fund. Table 2 provides a list of these potential and possibly eligible countries. If applications for the Trust Fund are received from these countries, such applications will be held at bay. Once applicant countries become Codex members, their applications will be considered.
