UPDATE ON THE OPERATION OF THE STANDARDS AND TRADE DEVELOPMENT FACILITY

Note by the Secretariat¹

Overview

1. The Standards and Trade Development Facility (STDF) is both a financing and a coordination mechanism. Its aim is to assist developing countries enhance their capacity to meet international sanitary and phytosanitary (SPS) standards, improving the human health, animal health and phytosanitary situation, and thus gaining and maintaining market access. Grant financing is available for private and public organizations in developing countries seeking to comply with international SPS standards and hence gain or maintain market access. The STDF provides funds for two types of grants: project preparation grants (PPGs) and project grants.²

2. Applications for STDF funding may be made at any point in the year. The STDF Working Group meets three times per year to consider funding requests. The next Working Group meeting is scheduled for 16-17 October 2006. The deadline for funding submissions to be considered at this meeting is 18 August 2006. Applications received after that date will be considered at the next Working Group meeting in 2007. Further information on the STDF, including the Business Plan, application forms and information on projects approved can be found at the STDF website (www.standardsfacility.org). The website also contains training materials collected from partner agencies and a link to the database on SPS technical activities.

3. The STDF has only limited resources at present and new contributions are being actively sought from existing and new donors. Implementation of further projects and project preparation grants can only commence after new financial resources have been injected into the STDF.

Establishment of STDF Task Force

4. On 8 June 2006, the Policy Committee met in Geneva and discussed a number of strategic issues arising from the evaluation of the STDF completed in December 2005.³ The Committee agreed to establish a Task Force which will report with recommendations on the establishment of a medium-term strategic plan for the STDF including recommendations on concomitant multi-annual donor funding. It was decided that the medium-term plan would be based on annual donor funding of approximately US\$ 5 million per year and contain recommendations on appropriate management arrangements – including in relation to the tasks and responsibilities of partner organizations and the

STDF Secretariat. The Task Force will also establish criteria for membership of and observer status in the STDF.

5. It was agreed that the Task Force should be chaired by the UK, one of the donor countries currently participating in the donor rotation mechanism. The Task Force comprises representatives of all five partner agencies (FAO, OIE, World Bank, WHO and WTO) and representative of seven donors.

6. The Task Force held its first meeting on 29 June 2006 in Geneva. At the meeting, it was agreed that the STDF's coordinating role should be strengthened. It was suggested that this coordination function could be improved through better reporting and an increase in the exchange and flow of information on SPS-related technical assistance, in combination with an increased focus on project development and the elaboration of project preparation grants. The Task Force considered that this coordination task would be best performed by a core group of experts within the WTO Secretariat. The Task Force will submit a preliminary report to the next Working Group meeting on 16-17 October 2006. A final report will be submitted for adoption by the Policy Committee at a meeting in the first quarter of 2007.

New projects approved

7. A total of seven project grant applications and three project preparation grants (PPGs) were considered by the STDF Working Group at its meeting on 9 June 2006. A further two projects were resubmitted from previous meetings. The total value of project grant and PPG applications submitted amounted to US\$ 4,127,785. Of these funding requests, a total of 3 projects and 1 PPG were approved for funding. The projects were accepted conditional on a number of amendments to the project documents and the injection of new funds into the STDF. With the approval of these funding requests, the total number of projects funded by the STDF amounts to 22 and the number of PPGs funded to 21.

On-going and completed projects

8. Table 3 provides an overview of the implementation status of STDF projects and project preparation grants. Summaries on the on-going status of STDF projects and accompanying reports will soon be added to the STDF website.

9. A number of STDF projects are scheduled to finish in 2006. One such project is the STDF database on SPS-related technical assistance and capacity building projects (STDF 5). The database covers national as well as regional projects for the period 2001 to 2003. Data is reported from the five partner organizations, multilateral agencies, regional and bilateral donors and has been taken from the existing WTO/OECD Trade-Related Technical Assistance and Capacity Building database. The database can be accessed at http://stdfdb.wto.org/.

10. The logic behind the creation of the STDF database was to have a dedicated database on SPS specific technical assistance – at that time the WTO/OECD Trade Capacity Building Database did not distinguish between SPS and TBT data – and to ensure that there was no under-reporting in particular with respect to the activities of STDF partners. The STDF database solved the problem of under-reporting of partner activities, but comparison of submissions by Members to the SPS Committee on technical assistance activities with their entries from the WTO/OECD Trade Capacity Building Database highlighted a far more serious problem of under-reporting. Given that funding for the STDF database expired at the end of 2005, the focus is now on ensuring full reporting on the WTO/OECD Trade Capacity Building Database. SPS and TBT data has now been separated and additional entries are being made on WTO/OECD Trade Capacity Building database to reflect more fully the activities of donors and partner agencies. A document evaluating the data reported on both databases will be circulated to the SPS Committee in due course.

11. Another project which has been completed concerns the development of a veterinary capacity evaluation tool by the OIE in collaboration with the Inter-American Institute for Co-operation on Agriculture (IICA) (STDF 14). The tool builds on IICA work with the Performance Vision and Strategy tool. The project has been field tested in Latin American countries and its application in Africa was considered at an OIE Seminar on Animal Health Policies, in N'Djamena, Chad, on 13-15 February 2006. The capacity evaluation tool was formally adopted at the 74th Annual General Session of the International Committee of the OIE on 21-26 May 2006.
