## TECHNICAL ASSISTANCE TO DEVELOPING COUNTRIES PROVIDED BY CANADA

Submission by Canada

The following communication, dated 6 October 2006, is being circulated at the request of the Delegation of Canada.

- 1. Canada would like to provide an update to its submission made at the 10-11 November 1999 meeting (G/SPS/GEN/143/Rev.1/Add.1) with regard to technical assistance. Canada submits the following compilations of technical assistance provided to developing countries between January 2000 and December 2004, in accordance with Article 9 of the Agreement on the Application of Sanitary and Phytosanitary (SPS) Measures (see attached tables¹). The assistance was primarily aimed at facilitating countries' adjustment to, and compliance with, sanitary and phytosanitary measures in their export markets and to improve their capacity in developing and implementing their SPS measures based on sound science. The attached tables may not constitute a complete compilation of all relevant technical assistance delivered given the number of Canadian government departments and agencies and the variety of delivery programs involved.
- 2. The monetary value of the technical assistance given amounted to over CDN\$10 million between January 2000 and December 2004. It should be noted that, in many cases, the organizations providing the assistance also made additional in-kind contributions to projects.
- 3. Assistance was given to 59 Member, Observer and other countries, mainly in Central America, but also in the Caribbean, South America, the Asia-Pacific region, Central Asia, Eastern Europe, and Africa. Assistance was directed to both individual countries and groups of countries or regional organizations such as the Caribbean community (CARICOM), the Organisation of American States (OAS), the Central American 4 (CA4), the Association of South-East Asian Nations (ASEAN), and the Asia Pacific Economic Cooperation (APEC) group.
- 4. In addition, in January 2004, Canada contributed CDN \$1.2M to the Food and Agriculture Organization of the United Nations (FAO) to be invested equally in IPPC and Codex Trust Funds to help increase developing country participation in their respective standards development and adoption processes, as well as to support capacity-building activities in those countries over three years (i.e. 2004-2007).

- 5. Canada's assistance addressed three of the four broad categories listed in G/SPS/GEN/206: information, training, and "soft" infrastructure development (but not "hard" infrastructure development). Assistance from Canada covered most of the "typical areas of competence" listed under the headings of food safety, animal health and plant protection, in the Annex of G/SPS/GEN/206.
- 6. In all, 76 projects are listed for the period January 2000 to December 2004 with the majority of projects related to food safety and hazard analysis critical control points training (HACCP). Some of the projects listed are multi-year projects but are only listed for the year in which the project was initiated.
- 7. In the year 2000, one project was related to animal health and five to food safety.
- 8. In 2001, 12 projects were related to food safety, one to a combination of animal health and food safety and one to a combination of animal health, plant health and food safety.
- 9. In 2002, four projects were related to animal health, two to plant health, 12 to food safety, one to a combination of plant health and food safety, and three to a combination of animal health, plant health and food safety.
- 10. In 2003, one project was related to animal health, three were related to plant health, 10 related to food safety, one to a combination of animal health and food safety, and six to a combination of animal health, plant health and food safety.
- 11. In 2004, one project was related to animal health, one to plant health, seven to food safety, two to a combination of animal health and food safety, and two to a combination of animal health, plant health, and food safety.
