# TECHNICAL ASSISTANCE TO DEVELOPING COUNTRIES PROVIDED BY CANADA

#### Communication from Canada

The following communication, received on 23 February 2007, is being circulated at the request of the Delegation of Canada.

- 1. Canada would like to provide an update to its submission made at the October 2006 meeting with regard to technical assistance (G/SPS/GEN/728). Canada submits the following compilations of technical assistance provided to developing countries between January 2005 and December 2006, in accordance with Article 9 of the *Agreement on the Application of Sanitary and Phytosanitary (SPS) Measures* (see attached table<sup>1</sup>). The assistance was primarily aimed at facilitating countries' adjustment to, and compliance with sanitary and phytosanitary measures in their export markets and to improve their capacity in developing and implementing their SPS measures based on sound science. The attached table may not constitute a complete compilation of all relevant technical assistance delivered given the number of Canadian government departments and agencies and the variety of delivery programs involved.
- 2. The monetary value of the technical assistance committed to amounted to over CDN \$7.5 million between January 2005 and December 2006. It should be noted that, in many cases, the organizations providing the assistance also made additional in-kind contributions to projects.
- 3. Assistance was given to 54 Member, Observer and other countries, in Central America, the Caribbean, South America, the Asia-Pacific region, Central Asia, Eastern Europe, and Africa. Assistance was directed to both individual countries and groups of countries or regional organizations such as the Caribbean Community (CARICOM) and the Asia Pacific Economic Cooperation (APEC) group.
- 4. In addition, in March 2005, Canada signed a Memorandum of Understanding with the WTO over a contribution of CDN \$400,000 to the Standards and Trade Development Facility (STDF) to assist developing countries in improving their expertise and capacity to analyze and implement international SPS standards.
- 5. Canada's assistance addressed three of the four broad categories listed in G/SPS/GEN/206<sup>2</sup>: information; training; and "soft" infrastructure development (but not "hard" infrastructure development). Assistance from Canada covered most of the "typical areas of competence" listed

under the headings of food safety, animal health and plant protection, in the Annex of G/SPS/GEN/206.

6. In all, 15 projects are listed for the period January to December 2005 and ten for the period January to December 2006 with the majority of projects related to food safety. Some of the projects listed are multi-year projects but are only listed for the year in which the project was initiated.
