CALL FOR COMMENTS ON A COMMISSION CONSULTATION ON THE REVIEW OF REGULATION (EC) NO 1774/2002 LAYING DOWN HEALTH RULES CONCERNING ANIMAL BY-PRODUCTS NOT INTENDED FOR HUMAN CONSUMPTION¹

Communication from the European Communities

The following communication, received on 25 April 2007, is being circulated at the request of the Delegation of the European Communities.

- 1. In 2006, in document G/SPS/GEN/719 (8 August 2006) "Call for early comments on a Commission Report on animal by products not intended for human consumption", the European Communities called for comments on a report to the European Parliament and the Council. In supplement to the above, the Commission has considered the issue and is now launching an **online public consultation**, in the form of a questionnaire, in order to gather data concerning the potential impacts of the review of the animal by-products Regulation (see background).

The European Commission will take into account all comments in finalizing an impact assessment report and in presenting a draft "Regulation of the European Parliament and of the Council amending the Regulation (EC) No 1774/2002 laying down health rules concerning animal by-products not intended for human consumption" that will be communicated to the WTO Secretariat in due course.

BACKGROUND

- 5. In document G/SPS/N/EEC/103 (24 November 2000) the European Communities notified a regulatory proposal that later became *Regulation (EC) No 1774/2002 of the European Parliament and of the Council of 3 October 2002 laying down health rules concerning animal by-products not intended for human consumption.* This Regulation established conditions to ensure that the products imported are of a hygiene standard equal or equivalent to the standards applied in the European Communities. To this end, it introduced a system for approval of third countries and their establishments, an EC inspection (or audit) procedure, and model health certificates, which must accompany the imported products. It entered into force on 1 November 2002 and applied as of 1 May 2003.
- 6. The Commission tries in all circumstances to comply with Article 5.6 of the SPS Agreement, i. e. the measures should not be more trade-restrictive than required to achieve the appropriate level of sanitary or phytosanitary protection, taking into account technical and economic feasibility. This can be verified in the annexed table in which a comprehensive view of the modifications is presented.
