UPDATE ON THE OPERATION OF THE STANDARDS AND TRADE DEVELOPMENT FACILITY

Note by the Secretariat¹

Overview

1. The Standards and Trade Development Facility (STDF) is both a coordinating and a financing mechanism. Its Medium Term Strategy (2007-2011), adopted in December 2006, places greater emphasis on the STDF as a vehicle for coordination among technical cooperation providers, for the exchange of experience, and for the dissemination of good practice in the provision and receipt of SPS-related technical co-operation. The STDF continues to provide funding for projects, but with more focus on project development through the use of project preparation grants (PPGs) and on the mobilization of donors to fund resultant projects.

2. To implement the Medium Term Strategy, a target level of annual funding of US\$5 million has been established by the STDF Policy Committee. This target is still some way from being achieved for 2007 and forthcoming years, and a funding strategy is being developed. This strategy will aim to raise the profile of the STDF in the wider donor community, pursue contacts with existing and potential donors, and complement the broader Aid for Trade and Enhanced Integrated Framework (IF) initiatives.

3. At its last meeting on 2 March 2007, the STDF Working Group approved a further three projects and three project preparation grants for funding, and withdrew its approval for four projects due to implementation delays of over one year. For these four projects, applicants were invited to update their applications and re-apply for funding at the next meeting of the Working Group. The total number of projects and PPGs approved by the STDF currently stands at 22 projects and 23 PPGs. Six projects were completed in 2006 and evaluations of three of these projects are in the process of being finalized. Further evaluations are commissioned and/or planned for all five STDF projects finishing in 2007.

4. Applications for STDF funding may be made at any point in the year. Provided that applications are received within the appropriate deadline, they will be considered at the following STDF Working Group. The Working Group will meet twice more in 2007, on 29 June and (tentatively) on 20 October 2007. The deadline for the submission of project proposals for the October meeting is 2 September 2007. Regional consultations

5. The Medium Term Strategy places greater emphasis on the STDF acting as a vehicle for coordination among technical cooperation providers and beneficiaries. As part of its coordination function, the STDF will organize regional consultations which will examine issues related to the provision and receipt of SPS-related technical cooperation. To catalyze these consultations, research on tracking flows of SPS-related technical cooperation and the continuing needs of recipient countries in the SPS area will be carried out. The consultations will also provide an opportunity for donors, beneficiaries and other relevant organizations to identify good practice and to establish future SPS-related technical cooperation priorities.

6. On the basis of an evaluation of the pilot events, further regional consultations would be planned for 2008 and beyond. The intention would be to cover all regions during the life of the Medium Term Strategy.

Funding strategy

7. The STDF has limited resources and new contributions from donors are actively being sought to implement its work programme for 2007 and future years. A new funding strategy is being developed which seeks to raise the profile of the STDF in the wider donor community. Key to this awareness raising is complementing the broader Aid for Trade and Enhanced Integrated Framework (IF) initiatives. Significant efforts will be made to publicize the STDF in these ongoing programmes and their events.

8. Developing synergies between the STDF and the IF has been successful in the past, in particular by building on the Diagnostic Trade Integration Studies (DTIS) and designing projects from the priorities identified in these documents. The enhancement of the IF provides new opportunities for future STDF - IF collaboration. In particular, projects developed under STDF PPGs and reflecting DTIS priorities could be picked up for funding through the Enhanced IF. To this end, STDF's project development function and catalyst role will be brought to the attention of IF national coordinating committees and donors.

New projects approved

9. A total of seven project grant applications and two PPGs were considered by the STDF Working Group at its meeting on 2 March 2007. Of these funding requests, a total of three projects and two PPGs were approved for funding. It is to be noted that implementation of these projects depends on the conclusion and signature of the general framework agreement between WTO and FAO regulating the implementation and supervision of STDF projects.

10. In line with the STDF's function to catalyze resources in the SPS area from the broader donor community, project STDF 113 in Burundi was approved by the STDF Working Group but a decision was taken to seek funding outside the Facility. Discussions are in an advanced stage on the funding of this project by a bilateral donor. Likewise, a PPG for project STDF 171 was approved with the same intention of soliciting funds from the broader donor community.

On-going and completed projects

11. Table 3 below provides an overview of the implementation status of STDF projects and PPGs. Summaries on projects, PPGs and accompanying reports have been updated and will soon be available on the STDF website (www.standardsfacility.org). It is to be noted that implementation of project STDF 133 will be supervised by the IPPC Secretariat. Its commencement therefore depends on the conclusion and signature of the general framework agreement between WTO and FAO. For the supervision of project STDF 145, negotiations with the local World Bank office in Rwanda are ongoing.

12. Evaluations of three STDF projects are ongoing. Evaluation reports will be presented and discussed at the next meeting of the STDF Working Group and made available on the STDF website. The three projects are as follows:

- STDF 14: Development of a veterinary capacity evaluation tool by the OIE in collaboration with IICA
- STDF 37: Organization of a workshop addressing issues surrounding the implementation of ISPM No. 15 (Guidelines for regulating wood packaging material in international trade)

• STDF 56: Development of a Manual of Good Practice for Animal Feeding and providing practical support and guidance for the implementation of the Codex Code of Practice on Good Animal Feeding

Project approvals withdrawn

13. Four projects were withdrawn for funding at the March 2007 Working Group meeting. Implementation of each project had been outstanding for over one year. In the case of three projects (STDF 62, 64 and 69), the delay was due to failure to agree implementation arrangements for STDF projects between FAO, the World Bank, and the WTO. To rectify this situation, agreement on a general framework agreement is at an advanced stage with FAO. It is hoped that a similar agreement will be signed with the World Bank shortly.

14. For one additional project, STDF 48, the withdrawal of approval was caused by additional updates to the project document requested by the Working Group and delays on the part of the applicant in providing the information sought. In all cases, the applicants were invited to resubmit their funding applications.
