# UPDATE ON THE OPERATION OF THE STANDARDS AND TRADE DEVELOPMENT FACILITY

Note by the Secretariat<sup>1</sup>

#### Overview

1. The Standards and Trade Development Facility (STDF) is a global programme in capacity building and technical cooperation established by the Food and Agriculture Organization of the United Nations (FAO), the World Organization for Animal Health (OIE), the World Bank, the World Health Organization (WHO) and the World Trade Organization (WTO). It assists developing countries to meet with food safety, animal and plant health (sanitary and phytosanitary or SPS) measures in international trade. A range of other organizations - including the International Trade Centre (ITC), the Organization for Economic and Development (OECD), the United Nations Industrial Development Organization (UNIDO) and the United Nations Conference on Trade and Development (UNCTAD) – as well as donors and developing countries also participate in the Facility.<sup>2</sup>

#### 2. The STDF has two main aims:

- to assist developing countries enhance their expertise and capacity to analyze and to implement international SPS standards, improving their human, animal and plant health situation, and thus ability to gain and maintain market access; and
- to act as a vehicle for awareness raising on the importance of SPS issues, coordination among technical cooperation providers, the mobilization of funds, the exchange of experience and the dissemination of good practice in relation to the provision and receipt of SPS-related technical cooperation.

#### **Evaluation**

- 3. An independent evaluation of the STDF was completed on 14 November 2008.<sup>3</sup> The review judged the overall performance of the STDF to be good, and in many important areas very good. Furthermore, the performance of the Secretariat was highly rated by virtually all stakeholders and by the evaluator. The final report has been circulated separately to the SPS Committee as document G/SPS/GEN/899 and can also be downloaded on the WTO SPS gateway.
- 4. The evaluation was discussed by the STDF Policy Committee on 16 December 2008 and led to a review of the STDF Operational Rules and Operating Plan for 2009. The new documents

incorporate various recommendations made in the evaluation and place further emphasis on STDF's coordination function. According to the evaluator, the STDF's future lies in coordination "since it has a comparative advantage here and can play a unique role in assisting developing countries in the future". Both documents can be downloaded from the STDF website at: www.standardsfacility.org.

5. Other recommendations to improve the STDF's work related to the information flow and the STDF website are currently being implemented. The evaluation concluded that the Secretariat and the partners, donors, observers and recipient countries have a shared responsibility to make STDF's existence and activities more widely known and to raise its profile. There is a need to improve the funding situation to meet the target of US\$5 million per year, preferably in multi-annual commitments, to implement the STDF work programme for 2009 and beyond.

#### Coordination

- 6. The STDF, in collaboration with the OECD and the WTO Secretariat, organized a workshop on Good Practice in SPS-Related Technical Cooperation on 6 October 2008. The meeting was attended by some 250 persons including delegates from the SPS Committee and 60 officials from developing countries. The workshop provided an opportunity to consider the Paris Principles on Aid Effectiveness in the context of the highly technical area of SPS-related technical cooperation and presented the findings of the STDF/OECD research to identify elements of good practice in the design, implementation, outputs and the achievement of higher-order objectives for projects in East Africa, Central America and the Greater Mekong Delta Sub-Region.
- 7. The workshop concluded that while there is clarity about what should be avoided in technical cooperation, there is less clarity about how to practically implement the Paris Principles on Aid Effectiveness on the ground. Another conclusion focused on the importance of measuring the impact of SPS assistance on trade performance and the need to develop and systematically apply indicators for this purpose. The research work built on previous STDF activities in East Africa, Central America and the Greater Mekong Delta Sub-Region, carried out as part of the Aid for Trade initiative, and was based on a survey (G/SPS/GEN/816 and Add.1), which requested WTO Members and OECD contact points to nominate SPS-related projects in these regions that could be considered as examples of good practice.
- 8. A summary report of the workshop (<u>G/SPS/R/52</u>), presentations and podcasts of discussions are available on the <u>WTO SPS gateway</u>. The findings of the regional research work were published in three regional research papers in September 2008.<sup>4</sup> An overview and synthesis of the findings of the regional research on good practice is available in <u>G/SPS/GEN/875</u>. In addition, the Secretariat has prepared a <u>briefing note</u> on the conclusions of the good practice work for general distribution.
- 9. The STDF prepared a desk study (G/SPS/GEN/900) on SPS needs and assistance of eight Least Developed Countries (LDCs), i.e. Benin, Cambodia, Lao PDR, Lesotho, Mozambique, Rwanda, Senegal and Yemen. The study was based on a review of existing needs assessments, notably the Diagnostic Trade Integration Studies prepared under the Enhanced IF and other publicly available information. The report complemented and strengthened UNIDO's broader programme proposals aimed at addressing the supply-side constraints of the eight LDCs and identified areas where future SPS technical cooperation activities with a positive trade effect might be focused. The final report

was presented at the <u>LDC Ministerial Conference on Aid for Trade</u> on 19-20 November 2008 in Siem Reap, Cambodia, jointly organized by WTO and UNIDO.

- 10. As part of its coordination role, the Secretariat prepared a background paper for the "Open-Ended Working Group for the Development of an IPPC Capacity Building Strategy" held in Rome, Italy, from 8-12 December 2008 (G/SPS/GEN/898). The objective of the report was to identify current flows of phytosanitary technical cooperation, examine how phytosanitary needs are evaluated and discuss how these can be mainstreamed into national development plans. The Secretariat also participated in an International Conference on "Sharing Innovative Agribusiness Solutions" organized by UNIDO in Cairo, Egypt, on 26-27 November 2008.
- 11. The revised STDF Operating Plan contains a detailed description of coordination activities planned for 2009. This includes the organization of two global thematic events on SPS capacity building and cost-benefit analysis (25 June 2009, back-to- back with the SPS Committee) and on SPS risks and climate change (date and venue to be confirmed). New research work will also be conducted on the development of indicators to evaluate the impact of SPS capacity building and on possible synergies between trade facilitation and STDF work.
- 12. At regional level, the STDF is planning to organize a meeting by mid-2009 to coordinate responses to combat fruit fly in West Africa. The meeting will provide an opportunity for national and regional organizations, donors and other stakeholders to discuss mechanisms to control fruit fly and mobilize funds for a multi-year Action Plan. More information on STDF's work in this area can be found on the STDF website. Consideration will also be given to holding one additional regional consultation similar to the ones held in 2008 in Central America, East Africa and the Greater Mekong Delta Sub-Region.
- 13. At national level, the STDF will continue its collaboration with the Enhanced IF Secretariat and the Aid for Trade initiative to increase the awareness of SPS-related issues and mobilize resources. The STDF is closely involved in an ongoing Aid for Trade activity in Peru funded by the Inter-American Development Bank (IADB). A study examining the need for and provision of SPS-related technical cooperation including the need to design a comprehensive national action plan will be presented in early 2009.

#### **Project development**

- 14. Project preparation grants (PPGs) are a key mechanism for future STDF programme development. PPGs help overcome constraints faced by developing countries in the articulation of their needs and are a mechanism for ensuring synergy with other on-going initiatives, in particular the Enhanced IF and the Aid for Trade. Greater reliance will be placed on the use of PPGs to provide a basis for donor interventions and as a vehicle for the mobilization of funds. A total of 31 PPGs have been approved and funded by the STDF since its inception.
- 15. At the STDF Working Group meeting in October 2008, one PPG was approved:
  - STDF 268: Harmonize the Legal, Regulatory and Institutional Framework for Sanitary and Phytosanitary (SPS) Control Management System (Tanzania).

#### **Project funding**

16. An overview of the current status of STDF projects is provided in Annex I. At the STDF Working Group meeting in October 2008, three new projects were approved for funding:

- STDF 116 rev.1: Development and implementation of a traceability system in the livestock sector in Costa Rica:
- STDF 155: Nicaragua market oriented training service on standards application; and
- STDF 255: Regional Initiative on the fight against fruit flies in West Africa.
- 17. It is to be noted that the <u>STDF Operational Rules</u>, as revised and adopted in December 2008 by the STDF Policy Committee, include new eligibility criteria for STDF-funded projects. In the future, funding will be dependent on the beneficiary country or countries' classification in the OECD Development Assistance Committee List of ODA recipients. Applications for STDF funding can be made at any point in the year but should be received <u>60</u> working days in advance of each Working Group meeting in order to be considered at that meeting. Forthcoming deadlines for submission of funding applications are as follows:
  - 3 April 2009; and
  - 7 August 2009.

#### **Information dissemination**

- 18. Various activities to disseminate information and increase awareness about the STDF have been and will be carried out in 2009. Following the evaluation, work is underway to improve the content and functionality of the STDF website. This includes updates and the inclusion of new information and translation of the content into French and Spanish. Publication of the tri-annual STDF newsletter will continue in 2009. The first in a new series of STDF briefings aimed at disseminating information on STDF's activities more widely was published in December 2008. Work was also initiated on a short film on the importance of SPS capacity building for international trade and economic development.
- 19. Finally, presentations and briefings on the STDF were made as part of WTO's regular technical assistance programme and at various other meetings, both inside and outside WTO. This included STDF's participation in the FAO/WHO Coordinating Committee for the Codex Alimentarius Commission for Europe in Warsaw, Poland (7-10 October 2008) and for North America and South West Pacific in Nuku'alofa, Tonga (27-30 October 2008).

#### **Call for evaluators**

20. All projects funded by the STDF include a provision for an independent ex-post evaluation. For this purpose, the Secretariat is tasked to maintain a roster of consultants. The evaluation of projects, however, is currently being delayed due to the lack of suitably qualified consultants. The recent review of the Facility recommended the STDF Working Group members and observers and their organizations to renew their efforts to supply the STDF Secretariat with names of suitably qualified persons to carry out such evaluations. In addition, the Secretariat would like to solicit the interest of consultants to carry out evaluations of STDF projects through the SPS Committee.
