UPDATE ON THE OPERATION OF THE STANDARDS AND TRADE DEVELOPMENT FACILITY

Note by the Secretariat¹

Overview

1. The Standards and Trade Development Facility (STDF) is a global programme in sanitary and phytosanitary (SPS) capacity building and technical cooperation established by the Food and Agriculture Organization of the United Nations (FAO), the World Organization for Animal Health (OIE), the World Bank, the World Health Organization (WHO) and the World Trade Organization (WTO). A range of other organizations - including the International Trade Centre (ITC), the Organization for Economic Cooperation and Development (OECD), the United Nations Industrial Development Organization (UNIDO) and the United Nations Conference on Trade and Development (UNCTAD) – as well as donors and developing countries also participate in the Facility.²

2. The STDF has two main aims:

- to assist developing countries enhance their expertise and capacity to analyze and implement international SPS standards, improving their human, animal and plant health situation, and thus ability to gain and maintain market access; and
- to act as a vehicle for awareness raising on the importance of SPS issues, coordination among technical cooperation providers, the mobilization of funds, the exchange of experience and the dissemination of good practice in relation to the provision and receipt of SPS-related technical cooperation.
- 3. This document provides an overview of STDF activities since the previous SPS Committee meeting in June 2009 in relation to the following three themes in the STDF's Operating Plan for 2009 (http://www.standardsfacility.org/files/various/STDF_198_Add.1_Operating_Plan_2009_Eng.pdf): (i) coordination and information dissemination; (ii) project development; and (iii) project funding.

Coordination and information dissemination

4. As part of the EC-funded "PAN-SPSO" programme, the STDF and the African Union Inter-African Bureau for Animal Resources (AU/IBAR), in close collaboration with the WTO, Codex, OIE and IPPC Secretariats, organized two "training-of-trainers" workshops held in Nairobi, Kenya (13-16 July) and in Bamako, Mali (20-23 July). The workshops were targeted at English- and French-

speaking officials of several Regional Economic Communities (RECs) and a selected group of African SPS experts. The STDF is also carrying out a scoping study on the establishment and functioning of regional and national SPS coordination mechanisms in Africa. The objective is to compile information about existing coordination mechanisms and provide guidelines on the feasibility and modalities available to further establish such mechanisms - both at regional and national levels.

- 5. The STDF Secretariat has organized three major events in the second half of 2009. In collaboration with the World Bank's Development Research Group, a seminar entitled: "Climate Change and Agriculture Trade: Risks and Responses" was organized in Washington, D.C. on 22-23 September. The meeting was attended by over 100 representatives from international organizations, regulatory and development agencies, research, academia and the private sector. Discussions on the first day focused on the connections between climate change, agricultural trade and food security. The second day focused on SPS risks and responses to climate change. Speakers emphasized that climate change is already having impacts on food safety and animal and plant health and that these are likely to become more intense, with implications for the future development and implementation of SPS-related standards. While some countries have started to consider how climate change will affect agricultural production and SPS risks, many are still ignoring or denying the linkages. Yet notwithstanding data gaps, action cannot wait. There was agreement that strengthening food safety, animal and plant health systems is critical to tackle the challenges faced. This will require more support to develop capacities in prediction, surveillance, diagnosis, risk assessment, regulatory frameworks, etc.
- 6. On 29-30 September, the STDF joined forces with ECOWAS to co-host a workshop in Bamako, Mali, on the implementation of a regional action plan to control fruit fly in West Africa, in close collaboration with the World Bank and the Europe-Africa-Caribbean-Pacific Liaison Committee (COLEACP). Close to 100 participants, including government representatives, private sector, civil society, research institutions and development partners, validated the regional action plan, prepared by COLEACP, and adopted the Bamako Declaration, outlining a roadmap of recommended actions to commence implementation of the action plan in the months to come.
- 7. A workshop on the use of economic analysis to inform SPS decision-making. organized by the STDF Secretariat, will be held on 30 October in Geneva back-to-back with the meeting of the SPS Committee. The workshop will discuss the costs and benefits of strengthening SPS systems. Relevant experiences and lessons from both developed and developing countries will be presented, as well as guidelines to assist countries in applying economic analysis in SPS decision-making. More information about these three events, including summary reports, background documentation and presentations, is available on the STDF website (http://www.standardsfacility.org). In addition, the STDF Secretariat will prepare short briefing notes summarizing the main discussions and conclusions emerging from the events.
- 8. The STDF Secretariat, in collaboration with the OECD, is undertaking a study on indicators to measure the performance and ensure sustainability of SPS-related technical cooperation. Building on earlier work on Good Practice in SPS-Related Technical Cooperation, STDF's work on SPS indicators is a direct response to the demand for a more rigorous monitoring and evaluation of Official Development Assistance (ODA) that is now at the forefront of the international development agenda. Inputs are being received from STDF partners, donors and beneficiaries, which will enable the study to highlight successful processes and indicators to quantify performance, as well as constraints faced. An introduction to this STDF work will be given to the OECD Development Assistance Committee (DAC)/Trade Committee Working Party meeting on Aid for Trade in November 2009. The study will be ready by the end of this year.

- 9. The STDF also participated in and contributed to the following events:
 - The East Asia and Pacific Regional Agribusiness Trade and Investment Conference, organized by the World Bank and the International Finance Corporation, in Singapore on 30-31 July. This event sought to initiate a long-term effort to stimulate increased intra-regional trade and investment in the agrifood sector, consistent with best practices in critical areas such as assuring compliance with food safety, environmental and social standards;
 - The APEC Food Safety Cooperation Forum (FSCF), held in Singapore on 30 July, to discuss successes and challenges faced in strengthening food safety systems within APEC; and in a workshop, as part of the FSCF meeting, entitled "Examination of Hot Issues in Risk Analysis", organized by the Partnership Training Institute Network (PTIN);
 - A workshop on WTO SPS Measures, organized by the Asian Development Bank Institute (ADBI) in collaboration with FAO, held in Bangkok, Thailand from 8 to 11 September, where more than 30 mid-level and senior agriculture officials were briefed on recent developments in the WTO SPS Committee and current STDF activities;
 - A roundtable on the development of the global Food Safety Knowledge Network (FSKN) organized by the Global Food Safety Initiative (GFSI) and Michigan State University, held in Washington, D.C. on 28 September. The FSKN aims to strengthen the food industry's response to the complex food safety knowledge and training challenges that affect emerging markets:
 - A session on SPS transparency and implications organized by the International Agricultural Trade Policy Council (IPC) at the WTO Public Forum (30 September);
 - WTO training seminars, including for Asian countries (Lao PDR, 3-7 August), and in Indonesia (6-8 October); and
 - The 19th Geneva Week for non WTO-resident Members and Observers in Geneva (26-30 October).
- 10. The STDF film: "Trading Safely: Protecting Health, Promoting Development", was shown at the Codex Alimentarius Commission in Rome on 3 June, and on the margins of the Second Global Aid for Trade Review in Geneva on 6-7 July, as well as in a large number of SPS-related training events. The film was widely distributed through STDF partners, donors and observers. The STDF is currently developing a short (8-minute) version of the film, as well as a short institutional clip about the mission and functions of the STDF. These two new products will be available on the STDF website by the end of the year.
- 11. of improvements have made the **STDF** website Α number been to (http://www.standardsfacility.org), and additional changes are underway. These changes include the addition of new links with film material developed by other organizations, as well as information received from Working Group members and observers on their existing and forthcoming SPS activities and initiatives. A compilation of information received in advance of the previous Working Group meeting is available on the website. Partners, donors and observers are encouraged to use the STDF website to exchange information on their work building capacity in the SPS area.

Project development

12. Project preparation grants (PPGs) are a key mechanism for future STDF programme development. PPGs help overcome constraints faced by developing countries in the articulation of


their needs and are a mechanism for ensuring synergy with other on-going initiatives, in particular the Enhanced Integrated Framework (EIF) and the Aid for Trade initiative. Greater reliance is placed on the use of PPGs to provide a basis for donor interventions and as a vehicle for the mobilization of funds. A total of 37 PPGs have been approved and funded by the STDF since its inception.


- 13. At the STDF Working Group meeting in June 2009, four PPGs were approved:
 - STDF/PPG/298: Capacity Building Programme on Pesticide Residues and other Harmful Substances in Cocoa in Africa (International Cocoa Organization ICCO);
 - STDF/PPG/302: Project Preparation Grant to Support the Competitiveness of Cabbage in the Niayes Region (Senegal);
 - STDF/PPG/303: Project Preparation Grant to Conduct a Total Diet Study for Sub-Saharan Africa (Centre Pasteur du Cameroun CPC);
 - STDF/PPG/305: Project Preparation Grant on Institutionalizing SPS for Agricultural Health and Food Safety Systems in Africa (African Union Commission).

Project funding

- 14. A total of 37 projects have been approved for STDF funding. At the STDF Working Group meeting in February 2009, one new project was approved for funding:
 - STDF/PG/259: Strengthening Vietnamese SPS capacities for trade by improving safety and quality of fresh vegetables using a value-chain approach.
- 15. An overview of the current status of STDF projects and PPGs is provided in Annex I. Since its inception, the STDF has devoted 61 per cent of project resources to Least Developed Countries (LDCs) and Other Low Income Countries (OLICs), as shown in Figure 1 below. Figure 2 indicates that 54 per cent of the number of STDF Projects and PPGs has gone to Sub-Saharan Africa, 15 per cent to Latin America and the Caribbean and 12 per cent to Asia. In addition, 14 per cent of projects and PPGs can be classified as global.

16. Applications for STDF funding can be made at any point in the year but should be received at least $\underline{60}$ working days in advance of each Working Group meeting in order to be considered at that meeting. The next deadline for the submission of project proposals is $\underline{24}$ December $\underline{2009}$.
