PROPOSED PROCESS FOR THE FOURTH REVIEW OF THE OPERATION AND IMPLEMENTATION OF THE AGREEMENT ON THE APPLICATION OF SANITARY AND PHYTOSANITARY MEASURES

NOTE BY THE SECRETARIAT¹

At the Fourth Session of the Ministerial Conference, Ministers instructed the Committee to review the operation and implementation of the SPS Agreement at least once every four years, pursuant to the provisions of Article 12.7 of the Agreement.² The Third Review was concluded by the Committee in March 2010 (G/SPS/53). In order to facilitate an efficient review process, the Secretariat, in consultation with the Chairperson, is proposing that the Committee agree to the following procedure. The Committee will be invited to agree on this procedure at its meeting of 17-18 October 2013.

- 1. The Review will initially be conducted through open-ended informal meetings of the Committee. The informal meetings will normally be scheduled back-to-back with the regular meetings of the Committee. Interpretation will be provided at the informal meetings. If necessary, further informal and special meetings of the Committee may be scheduled.
- 2. Members will be invited to identify issues for discussion as part of the Review, and subsequently to submit papers and propose specific actions on the issues under consideration. The Chairperson will propose the order in which issues will be considered at each informal meeting of the Committee, in light of the proposals and submissions received.
- 3. An item relating to the Review will be included in the agenda of each regular meeting of the Committee during the Review period, under which the Chairperson will provide an oral report on the informal Review process, including the issues discussed and conclusions reached. On the basis of this report, the SPS Committee will consider what further action may be appropriate.
- 4. The Secretariat will prepare a background document summarizing information regarding the implementation of the Agreement (e.g., notifications, technical assistance, dispute resolution), as well as the work of the Committee since the Third Review (e.g., specific trade concerns, issues considered by the Committee, decisions adopted). This document will be revised to also include background information on any specific issues proposed for consideration, and may serve as the basis for the Committee's report on the Fourth Review.
- 5. The Review process will be conducted on the basis of the following calendar, recognizing that some of the dates may need to be modified in light of other activities and resource constraints.
