1.2 Main Developments of the Committee during the Current Period

The Committee held its nineteenth, twentieth, twenty-first, twenty-second and twenty-third meetings on 25 February, 17-19 May, 21 July, 6 October and 10 November (G/TBT/M/18-22) respectively. At those meetings, the Committee heard statements concerning the implementation and administration of the Agreement, technical assistance and observer status. A number of Members informed the Committee of measures taken to ensure the implementation and administration of the Agreement. Several measures were brought to the attention of the Committee by Members who raised concerns about the potential adverse trade effects or inconsistency with the Agreement of those measures.

At its nineteenth meeting, the Committee carried out its Fifth Annual Review of the Implementation and Operation of the Agreement under Article 15.3 (G/TBT/8), and its Fifth Annual Review of the Code of Good Practice for the Preparation, Adoption and Application of Standards in Annex 3 (G/TBT/CS/1/Add.4, G/TBT/CS/2/Rev.6 and WTO TBT Standards Code Directory – fifth addition).

In order to promote information exchange and to facilitate discussion on technical assistance in the lead-up to the Second Triennial Review, a Workshop on Technical Assistance and Special and Differential Treatment in the Context of the Agreement was held on 19-20 July.

At its nineteenth, twentieth, twenty-first and twenty-second meetings, the Committee prepared for the Second Triennial Review of the Operation and Implementation of the Agreement under Article 15.4. The Second Triennial Review was concluded at the twenty-third meeting. Elements considered under the Review include the following: (i) Implementation and Administration of the Agreement; (ii) Notifications and Procedures for Information Exchange, (iii) International Standards, Guides and Recommendations; (iv) Conformity Assessment Procedures; (v) Technical Regulations; (vi) Technical Assistance and Special and Differential Treatment; and (vii) Other Elements (G/TBT/9). At that meeting, the Committee also adopted its Report (2000) to the Council for Trade in Goods (G/L/412).

III. NOTIFICATIONS

3.1 <u>Notifications made in the current year and since entry into force of the Agreement by Members and by the relevant Articles of the Agreement</u>

In 2000, Members submitted 611 notifications (G/TBT/Notif.00/1-613⁴). Since the entry into force of the Agreement on 1 January 1995 up to 31 December 2000, 3547 notifications have been made by 60 Members. Articles 2.9, 2.10, 3.2, 5.6, 5.7, and 7.2 were specified in 3144, 131, 3, 252, 49 and 3 notifications respectively. 108 notifications did not refer to any Articles.

3.1.2 Observation of the Recommended Comment Period by Members in the current year⁹

The Committee has recommended 60 days as a minimum length of time to be allowed for the presentation of comments from other Members (G/TBT/1/Rev.7). In 2000, Members allowed an average of 49.6 calendar days for comments. 142 notifications did not specify a comment period, stated as non-applicable or had a lapsed comment period. In 2000, the Secretariat held and participated in seminars on the Agreement and its related matters (e.g. standards, conformity assessment and metrology) with the cooperation of the ARSO, IDB, ISO, ITC, OIML, PTB, UNIDO, US Department of Commerce and the World Bank. They were held in Argentina, Bangladesh, Burkina Faso, France, Georgia, Jamaica, Kenya, Kuwait, Panama, Qatar and Thailand for countries from Africa, Asia, Latin America, the Middle East and Mediterranean region as well as economies in transition. Funds were provided by the WTO Hong Kong, China Funds to finance participants attending the Seminar in Thailand.

VII. CODE OF GOOD PRACTICE FOR THE PREPARATION, ADOPTION AND APPLICATION OF STANDARDS

Since the entry into force of the Agreement, 124 standardizing bodies from 85 Members have adhered to the Code of Good Practice.
