1.2 Main Developments of the Committee during the Current Period

The Committee held its fourth, fifth, sixth and seventh meetings on 1 March (G/TBT/M/4), 28 June (G/TBT/M/5), 16 and 22 October (G/TBT/M/6) respectively. At those meetings, the Committee heard statements on the implementation and administration of the Agreement.

On 27 February the Committee held a joint informal meeting with the Committee on Trade and Environment (CTE) to pursue discussions on the issue of eco-labelling. At that meeting, the representatives of the United States, European Communities, Czech Republic, Nordic countries, Chile, Japan and Canada presented their national and regional eco-labelling programmes. Canada presented a paper on eco-labelling to promote discussions on the issue (G/TBT/W/21-WT/CTE/W/21).

At its meeting in March, the Committee carried out its first Annual Review of the Implementation and Operation of the Agreement (G/TBT/3 and Corr.1) and of the Code of Good Practice for the Preparation, Adoption and Application of Standards contained in Annex 3 to the Agreement (G/TBT/CS/1 and Rev.1). It took decisions and recommendations concerning notification procedures and enquiry points (G/TBT/1/Rev.4) and agreed to grant observer status to the Organization for Economic Co-operation and Development (OECD) on an *ad hoc* basis pending final agreement on guidelines for observer status for international intergovernmental organizations in the WTO. The Committee also heard a presentation by the representative of the ISO on ISO/IEC guides relating to conformity assessment activities and held discussions on eco-labelling, avoidance of duplication and the ISO/IEC Code of Good Practice on Standardization.

At its meeting in June, the Committee held discussions on technical assistance and eco-labelling and heard a presentation by the representative from the International Laboratory Accreditation Conference (ILAC). It adopted the notification format under Article 10.7 as contained in document G/TBT/W/25 and agreed to grant observer status to the United Nations Economic Commission for Europe on a *ad hoc* basis pending final agreement on guidelines for observer status for international intergovernmental organizations in the WTO.

At its meetings in October, the Committee discussed and finalized its Report to the Singapore Ministerial Conference (G/TBT/W/32 and G/L/122), carried out its periodic examination under Article 12.10 of the Agreement on the special and differential treatment granted to developing country Members and heard a presentation by the representative from the United Nations Economic Commission for Europe (UN/ECE). It agreed to continue to grant observer status to those international intergovernmental organizations which were observers in the Committee on an *ad hoc* basis, under the rules and procedures adopted by the General Council, and to set up a small technical working group to study the relevant ISO/IEC Guides and how they might contribute to further the objectives of Articles 5 and 6 of the Agreement.

3.3 <u>Observation of the Recommended Comment Period by Members in the</u> current year⁵

The Committee has recommended 60 days as a minimum length of time to be allowed for the presentation of comments from other Members (G/TBT/1/Rev.4). In 1996, Members allowed an average of 46.9 calendar days for comments, the comment period had lapsed for 15 notifications, and the number of notifications that did not specify a comment period was 23. The table on the following pages gives the relevant data on the observation of the recommended comment period by each Member in 1996.

7. CODE OF GOOD PRACTICE FOR THE PREPARATION, ADOPTION AND APPLICATION OF STANDARDS

Overall, since the entry into force of the Agreement, 63 standardizing bodies from 46 Members have adhered to the Code of Good Practice. Notifications of acceptance of the Code by standardizing bodies are contained in documents G/TBT/CS/N/1-63. Document G/TBT/CS/2/Rev.1 contains the complete list by Member of standardizing bodies that have accepted the Code since 1 January 1995.

In 1996, 35 standardizing bodies from 21 Members accepted the Code. A list by Member of all standardizing bodies that have adhered to the Code in 1996 is in document G/TBT/CS/1/Add.1/Rev.1.

The second WTO TBT Standards Code Directory has been published by ISO/IEC Information Centre in January 1997.
